

ST JOHNS COUNTY EMERGENCY ORDER NO. 2019- 2

AN EMERGENCY ORDER RESCHEDULING NOTICED LAND USE ITEMS TO THE
SEPTEMBER 12, 2019 SPECIAL MEETING OF THE
ST. JOHNS COUNTY BOARD OF COUNTY COMMISSIONERS

WHEREAS, the Governor of the State of Florida has issued Executive Order No. 19-189 declaring a State of Emergency in certain Florida Counties including St. Johns pertaining to Hurricane Dorian; and

WHEREAS, a state of local emergency has been declared, pursuant to Chapter 252, Florida Statutes and St. Johns County Ordinance No. 2019-40, because of the severe threat that Hurricane Dorian poses to St. Johns County, Florida; and

WHEREAS, Executive Order No. 19-189 authorized waiver or deviation from the statutes, rules, ordinances, and orders administered by State, regional, and local agencies and other governmental bodies in responding to the emergency;

WHEREAS, the St. Johns County Board of County Commissioners, due to the on-going local state of emergency canceled the September 3, 2019 Regular Meeting of the Board;

WHEREAS, the St. Johns County Board of County Commissioners desires to provide reasonable notice, published in the *St. Augustine Record*, rescheduling certain Land Use Items from the September 3, 2019 Agenda to the September 12, 2019 Agenda;

NOW THEREFORE, in accordance with the emergency power vested in the St. Johns County Board of Commissioners pursuant to Chapter 252, Florida Statutes, and St. Johns County Ordinance No. 2019-40, it is hereby ordered that, notwithstanding anything to the contrary in the St. Johns County Land Development Code, Ordinance 99-51, as amended, and in Florida Statutes, the following items are hereby rescheduled and ordered to be noticed for the September 12, 2019 Public Hearing of the St. Johns County Board of County Commissioners at 3:30 PM in the St. Johns County Auditorium located at 500 San Sebastian View, St. Augustine, Florida:




