AN ORDINANCE OF THE COUNTY OF ST. JOHNS, STATE OF FLORIDA,
REZONING LANDS AS DESCRIBED HEREINAFTER FROM PRESENT
ZONING CLASSIFICATION OF OR TO CG.

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA:

SECTION 1. Pursuant to application of

WILLIAM G. SHELTON

zoning classification of OR on the following described lands:

The W 1/2 of Gov. Lot 1 lying West
of SR No. 12, excepting therefrom
that part conveyed to Whidden,
Valve and Gauge Repair Co., Inc.,
by deed recorded in official
Records Book 100, page 187, and
part conveyed to Daniel Polian in
Section 31, Township 4 South,
Range 27 East.

is hereby changed to CG.

SECTION 2. Nothing herein contained shall be deemed to impose
conditions, limitations, or requirements not applicable to all other land in the
zoning district wherein said lands are located.

SECTION 3. The Zoning Inspector is authorized to issue construction
permits allowed by classification as rezoned hereby.

SECTION 4. This Ordinance shall take effect immediately upon receipt
of official acknowledgement of the office of the Secretary of State to the Clerk
of the Board of County Commissioners that same has been filed.
