## ORDINANCE NO. 80-65 INTRODUCED BY: COMMISSIONER BENET

AN ORDINANCE OF THE COUNTY OF ST. JOHNS, STATE OF FLORIDA, PROVIDING FOR THE EXPANSION OF THE ANASTASIA MOSQUITO CONTROL DISTRICT TO INCLUDE PRECINCT 17

WHEREAS, the Board of County Commissioners of St. Johns
County has heretofore passed Ordinance 80-37 which provided for an
election of the registered electors residing within the existing
district and Precinct 17 which was requesting to be annexed, to be
determined by the majority of votes cast in each district, whether
the boundary would be changed; and

WHEREAS, the General Election held in November of 1980 approved the expansion of the Anastasia Mosquito Control District to include Precinct 17 by a majority vote in each of the areas; and

WHEREAS, the Board of County Commissioners of St. Johns
County finds that it is in the best interest of Precinct 17 and the
existing district to approve this expansion. Be it ordained by
the Board of County Commissioners of St. Johns County, Florida:

SECTION 1. It is ordained that the territory of the Anastasia Mosquito Control District is hereby expanded to include the area known as Precinct 17 in St. Johns County, Florida, which said Precinct 17 is more particularly described as follows:

Beginning at the intersection of Interstate Highway 95 and State Road 207; thence northeasterly along State Road 207 to Moultrie Creek; thence southeasterly and easterly following the course of said Moultrie Creek to U. S. Highway 1; thence northerly along U.S. Highway 1 to the southerly limits for the City of St. Augustine; thence easterly, southerly and easterly along the southerly limits for the City of St. Augustine to the run of Matanzas River; thence southerly along the run of Matanzas River to State Road 206; thence westerly along State Road 206 to Interstate Highway 95; thence northwesterly along Interstate Highway 95 to the point of beginning.

SECTION 2. This Ordinance shall take effect immediately upon receipt of official acknowledgment from the office of the Secretary of State to the Clerk of the Board of County Commissioners of St. Johns County, Florida that same has been filed.
