ORDINANCE NO. 2004- 04

AN ORDINANCE OF ST. JOHNS COUNTY, A POLITICAL SUBDIVISION OF THE STATE OF FLORIDA, AMENDING SECTION 8.01.02 OF ARTICLE VIII OF THE ST. JOHNS COUNTY LAND DEVELOPMENT CODE AS ADOPTED BY ORDINANCE 99-51, AS PREVIOUSLY AMENDED; THIS ORDINANCE SPECIFICALLY REVISES SECTION 8.01.02.A. RELATING TO A SCHOOL BOARD APPOINTED MEMBER POSITION OF THE COUNTY PLANNING AND ZONING AGENCY BEING A NON-VOTING POSITION DURING THE MEMBER'S CANDIDACY FOR ELECTED PUBLIC OFFICE; AND PROVIDING FOR AN EFFECTIVE DATE.

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY FLORIDA:

- Section 1. St. Johns County Ordinance # 99-51, as previously amended by Ordinance 2002-43, is hereby amended by adding the following subsection 7 to Section 8.01.02.A.
 - 7. If any member appoints a campaign treasurer for running for elected public office then that member's PZA office shall be vacated thereby; provided that, in regards only to a member appointed by the School Board, that member's office shall not be vacated thereby but shall then become a non-voting position during that member's period of candidacy
- Section 2. <u>Severance Clause</u>. It is the intent of the Board of County Commissioners of St. Johns County, and is hereby provided, that if any section, subsection, sentence, clause, phrase or provision of this Ordinance is held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not be construed as to render invalid or unconstitutional the remaining provisions of this Ordinance.
- Section 3. <u>Effective date</u>. This Ordinance shall take effect upon its being filed with the Department of State of Florida.
