## ORDINANCE NO. 2025- 1

AN ORDINANCE OF ST. JOHNS COUNTY, A POLITICAL SUBDIVISION OF THE STATE OF FLORIDA, MAKING CERTAIN FINDINGS; AMENDING SUBSECTION XI.D. (OFF-STREET PARKING – GERNREAL PROVISIONS), SECTION IX. (OFF-STREET PARKING AND LOADING), PONTE VEDRA ZONING DISTRICT REGULATIONS, ORDINANCE 2003-05, TO ADD PARKING REQUIREMENTS AND RESTRICTIONS FOR SAN JUAN DRIVE; PROVIDING A SAVINGS CLAUSE; PROVIDING FOR MODIFICATION DURING PUBLIC HEARING; PROVIDING FOR CORRECTION OF SCRIVENERS ERRORS; PROVIDING FOR INCLUSION AND CODIFICATION INTO THE PONTE VEDRA ZONING DISTRICT REGULATIONS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

#### **RECITALS**

WHEREAS, San Juan Drive is a residential drive located within the Municipal Service District of Ponte Vedra Beach, due to the nature of its landscaping and development patterns, presents a parking challenge that impacts public health, safety, and welfare unless properly regulated; and

WHEREAS, the Board of Trustees of the Municipal Service District of Ponte Vedra Beach ("MSD") has requested the County establish parking requirements and restrictions for San Juan Drive for the safety and well-being of the residents along San Juan Drive; and

WHEREAS, the MSD has indicated that automobiles and service vehicles parked on the paved part of San Juan Drive and within in the adjacent right-of-way coupled with a substantial increase in traffic has resulted in dangers to both vehicular and pedestrian traffic; and

WHEREAS, in May 2024, the County, at the request of the MSD, established a temporary "No Parking" zone on the west side of San Juan Drive from 318 San Juan Drive to the entrance of the Ponte Vedra Inn and Club's golf maintenance shed to enhance safety for residents who walk, jog, or bicycle on San Juan Drive; and

WHEREAS, such parking regulations are not land development regulations, but are due to be placed in the Ponte Vedra Zoning District Regulations for administrative convenience; and

WHEREAS, the County believes that Section IX of the County's current Ponte Vedra Zoning District Regulations, Ordinance No. 2003-05, as previously amended, pertaining to parking can be further improved by modifications herein.

## NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, as follows:

**Section 1. Findings.** The above Recitals are hereby adopted as Findings of Fact by the St. Johns County Board of County Commissioners and incorporated and made a part of this Ordinance.

**Section 2. Amendment.** Subsection IX.D. (Off-Street Parking – General Provisions), Section IX. (Off-Street Parking and Loading), Ponte Vedra Zoning District Regulations, Ordinance No. 2003-05, is hereby amended to add the following:

- 12. No parking is allowed in the right-of-way of San Juan Drive (a County owned/maintained local road) between Solana Road and Ponte Vedra Boulevard as depicted in Exhibit "A" (attached hereto and incorporated herein) in the Municipal Service District (MSD) of Ponte Vedra Beach, with the following exceptions:
  - a. Emergency and law enforcement vehicles;
  - b. Public service related vehicles, including but not limited to waste/recycling collection, U.S. Postal Service and mail/package delivery vehicles, and utility vehicles;
  - c. School buses providing transportation for public or private school students (for grades K-12);
  - d. Truck Tractors or Truck Tractor Semi Trailers, as those terms are defined in Chapters 316, Florida Statutes, but only when used to transport furniture, appliances and other belongings of a person moving into or moving out of a residence and only for so long as is reasonably necessary to load or unload. This exception does not apply to routine deliveries of furniture, appliances or other items to a residence at any other time than moving in or moving out of the residence.
  - e. Parking of non-commercial vehicles between the hours of 5 p.m. and 7:00 a.m. on weekdays (Monday through Friday), and at any time on weekends (Saturday and Sunday), except where no parking anytime signage is specifically posted by St. Johns County.

Parking shall not be allowed on sidewalks or within five (5) feet of an existing driveway.

Violations of this Subsection IX.D.12 shall be deemed violations of the St. Johns County Parking Ordinance (Ordinance 2015-30), as may be amended from time to time.

Parking/Placement of construction materials, dumpsters, construction debris containers, portable toilets, or any other construction related items is prohibited in the right-of-way of San Juan Drive as described in this subsection.

**Section 3.** Saving Clause. The remaining portions of the Ponte Vedra Zoning District Regulations, Ordinance 03-05, as amended, which are not in conflict with the provisions of this Ordinance, shall remain in full force and effect.

**Section 4. Modification.** It is the intent of the Board of County Commissioners that the provisions of this Ordinance may be modified as a result of considerations that may arise during public hearings. Such modifications shall be incorporated into the final version of the Ordinance adopted by the Board and filed with the Clerk.

Section 5. Inclusion and Codification. It is the intent of the Board of County Commissioners that the provisions of this Ordinance shall be codified and made part of the Ponte Vedra Zoning District Regulations, Ordinance No. 03-05, as amended, and that the sections and attachments of this Ordinance may be renumbered, reorganized, relettered, and appropriately incorporated into the Ponte Vedra Zoning District Regulations in order to accomplish such intentions.

Section 6. Scrivners Errors. It is the intent of the Board of County Commissioners that scriveners and typographica errors which do not change the tone or tenor of this Ordinance may be corrected during codification and may be authorized by the County Administrator or designee, without public hearing or further Board action, by filing a corrected or recodified copy of the same with the Clerk.

**Section 7**. **Severability**. It is the intent of the Board of County Commissioners, and is hereby provided, that if any section, subsection, sentence, clause, phrase or provision of this Ordinance is held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not be construed as to render invalid or unconstitutional the remaining provisions of this Ordinance.

**Section 8. Effective Date.** This Ordinance shall take effect upon a certified copy being filed with the Floirda Department of State.
