 - c) County Planning Department or Office
 - d) County Zoning Department or Office
 - e) Clerk of Courts

The Clerk shall not sign or accept the plat <u>for recording</u> until it has been signed by each of the above persons or entities described in a) through d) above and the construction bond unless waived, has been

delivered to the Clerk. If the plat is not signed and accepted by the Clerk for recording within 14 days from the date hereof, then the abovedescribed conditional approval and acceptances shall automatically terminate. If the plat is signed by the Clerk on or before such time, the conditions described herein, shall be deemed to have occurred.
