

RESOLUTION NO. 86-73

RESOLVED, that the Board of County Commissioners of St. Johns County, Florida, in the County Auditorium of the St. Johns County Administration Building, on July 22, 1986, at 10:10 o'clock a.m. upon petition of qualified land owners, will consider the advisability of exercising the power granted to it by Section 336.09, Florida Statutes 1981, and determine whether it will vacate, abandon, discontinue and close portions of certain streets, alleyways or roads described as follows:

All that certain Street known as CLEVELAND AVENUE, as the same lies between 2nd Street (Arthur St.) and 3rd Street (Hill St.) situated, lying and being between Blocks B-21 and B-23, of ST. SEBASTIAN SUBDIVISION of Government Lot 3, Section 12, Township 7 South, Range 29 East, according to map thereof recorded in Map Book 1, page 134 of the public records of St. Johns County, Florida.

and the notice required by Section 336.10, Florida Statutes 1981, is hereby authorized and directed to be published.

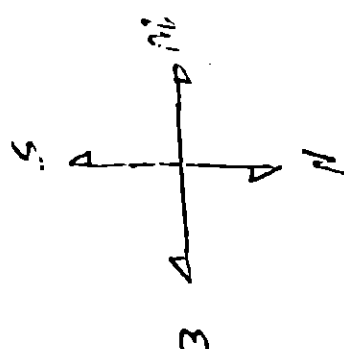
