RESOLUTION OF THE BOARD OF COUNTY
COMMISSIONERS, ST. JOHNS COUNTY, FLORIDA

as Owners, have tendered a drainage easement dated April 15

for a drainage system,

described easement is hereby accepted by the Board of County
Commissioners of St. Johns County, Florida. This acceptance
shall not be deemed an acceptance requiring construction
or maintenance of the drainage system.

The Clerk is instructed to record the drainage easement
at the County's expense.

EASEMENT

EASEMENT, Made this 15TH day of April, 1987,
between Lawrence H. Wiles and Josephine M. Wiles, his wife,
parties of the first part and ST. JOHNS COUNTY, FLORIDA, a
political subdivision of the State of Florida, whose address
is St. Johns County Courthouse, St. Augustine, Florida 32084,
party of the second part, witnesseth:

Parties of the first part, in consideration of the sum of
\$1.00 and other good and valuable considerations to them in hand
paid by party of the second part, the receipt whereof is hereby
acknowledged, do hereby grant, donate, bargain and convey to party
of the second part a perpetual easement in, over and under the
hereinafter described property, to the extent of the parties
of the first part's ownership thereof, to construct and maintain
all or part of a drainage system, over, in and under said easement;
said easement being in St. Johns County, Florida, and being more
particularly described as follows:

An easement for drainage purposes over a strip
of land 20 feet in width, being a part of that parcel of land
described in Official Record Book 517, page 674 of the public
records of St. Johns County, Florida, said easement being more
particularly described as follows:

The East 20 feet of the North One Half (N $\frac{1}{2}$) of
the South One Quarter (S $\frac{1}{4}$) of Government Lot 3, Section 31, Township
4 South, Range 27 East, of said County.

AND TO ALSO USE said easement for ingress and egress to maintain said drainage system.

TO HAVE AND TO HOLD the same unto the party of the second part, its successors and assigns forever.
