SCHEDULE A

The following streets and portions thereof and a portion of an alley, all lying westerly of State Road A-1-A in and adjacent to Sun Valley, according to map thereof recorded in Map Book 6, page 11 of the public records of St. Johns County, Florida, to wit:

Parcel 1: All of the alley lying between Lot 4 and Lot 26,
Block l

Parcel 2: That part of the South 30' of Government Lot 4, Section 27, Township 3 South, Range 29 East, St. Johns County, Florida lying westerly of a line being the southerly prolongation of the line dividing Lots 6 and 7, Block 1.

Parcel 3: All of West Side Boulevard.

Parcel 4: All of First Street North, less that part lying
within the right-of-way of State Road A-1-A, a 188 foot
right-of-way.
