## WARRANTY DEED

THIS WARRANTY DEED made this 22"d day of June, 1987 by W. D. DuPONT AND SONS, INC., a Florida Corporation, hereinafter called the grantor, to ST. JOHNS COUNTY, a political subdivision of the State of Florida, hereinafter called grantee, whose post office address is C/O Clerk of Court, St. Johns County, St. Johns County, St. Johns County, St. Johns County Courthouse, St. Augustine, Florida 32084.

(Wherever used herein the terms "grantor" and "grantee" include all the parties to this instrument and the heirs, legal representatives and assigns of individuals, and the successors and assigns of corporations)

WITNESSETH: That the grantor, for and in consideration of the sum of \$10.00 and other valuable considerations, receipt whereof is hereby acknowledged, hereby grants bargains, sells, aliens, remises, releases, conveys and confirms unto the grantee, all that certain land situate in St. Johns County, Florida viz:

TOGETHER with all the tenements, hereditament and appurtenances thereto belonging or in anywise appertaining.

TO HAVE AND TO HOLD, the same in fee simple forever.

AND the grantor hereby covenants with said grantee that the grantor is lawfully seized of said land in fee simple; that the grantor has good right and lawful authority to sell and convey said land; that the grantor hereby fully warrants the title to said land and will defend the same against the lawful claims of all persons whomsoever; and that said land is free of all encumbrances, except taxes accruing subsequent to December 31, 1986.
