A part of Henry Street as shown on the Plat of Rothchilds Addition to St. Augustine, Florida and being recorded in Map Book 3, Page 133, Public Records of St. Johns County, Florida, said part being bounded on the North by Block 1 of said Rothchilds Addition, bounded on the East by the West right-of-way line of Helen Street as shown on said plat, bounded on the South Block 18 of said plat and bounded on the Northeast by the Southwesterly right-of-way line of State Road No. 207 as now established for a 100 foot right-of-way; said part being more particularly described as follows:

For a Point of Beginning use the Southeast corner of Lot 1 of said Block 1; thence South 86° 30' West along the South line of said Block 1, 167.94 feet to the Southwesterly right-of-way line of said State Road No. 207, said point being on a curve to the right, non tangent to the last line, and having a radius, chord and chord bearing of 5779.56 feet, 63.57 feet and South 34° 28' 33" West; thence around the arc of said curve, 63.57 feet to its intersection with the North line of said Block 18; thence North 86° 30' East along said North line 207.22 feet to the West right-of-way line of Belen Street; thence North 3° 31' West, 50 feet to the Point of Beginning.
