Notice is hereby given that the Board of County Commissioners of St. Johns County, Florida, will hold a public hearing in the County Commission Room at the County Administration Building, 4020 Lewis Speedway (SR 16-A) U.S. #1 north, St. Augustine, Florida, at 10:30 o'clock a.m., on the 22nd day of September, 1987, to consider the following resolution correcting the Ponte Vedra Zoning District regulations, that were initially adopted by said Board on October 26, 1965, to-wit:

#### RESOLUTION 87-

It being called to the Board's attention that in Section X of the Zoning Resolution for an original zoning district of St. Johns County, Florida, to be known as the Ponte Vedra Zoning District, which Zoning Resolution established the regulations and restriction of said district pursuant to authority of Chapter 65-2171, Laws of Florida, Acts of 1965, and adopted by this Board October 26, 1965, contained a typographical error in that the St. Johns County Zoning Map, Zoning District No. 5, referred to in said Section X contained two index pages and thirteen pages of maps numbered 1 through 13 instead of three separate maps numbered 1, 2 and 3, as said Section X now reads, and it being suggested that said Section X be amended to correct this error. Whereupon, the following resolution was moved, seconded and carried:

RESOLVED THAT the original Zoning Resolution for an original zoning district of St. Johns County, Florida, to be known as the Ponte Vedra Zoning District, which Zoning Resolution originally established the regulations and restrictions of said district pursuant to authority of Chapter 65-2171, Laws of Florida, Acts of 1965, and adopted by the St. Johns County Board of County Commissioners October 26, 1965, Section X hereof be corrected as follows:
