RESOLVED by the Board of County Commissioners of St. Johns County, Florida, this 10 day of March, 19 87.

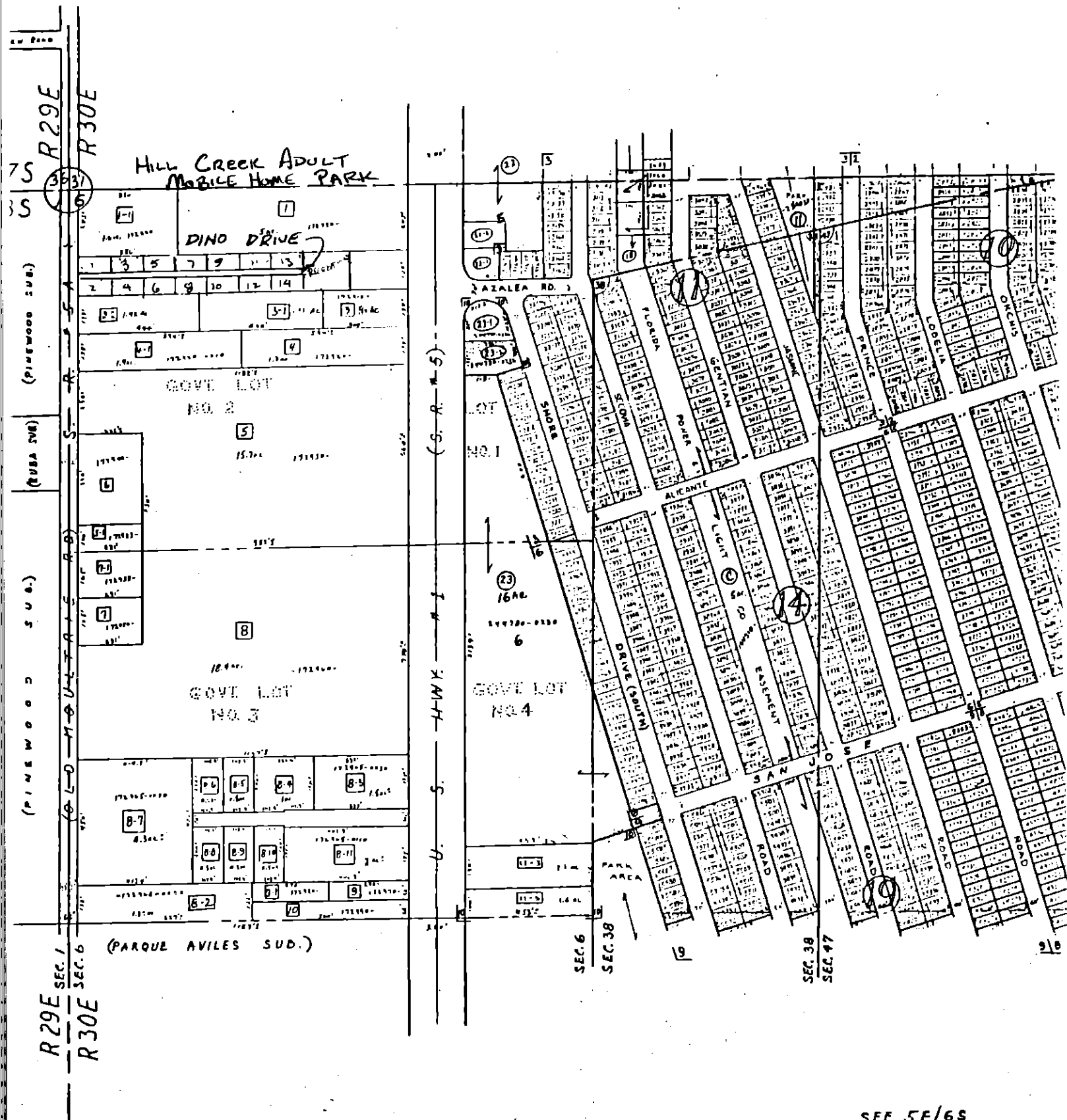
