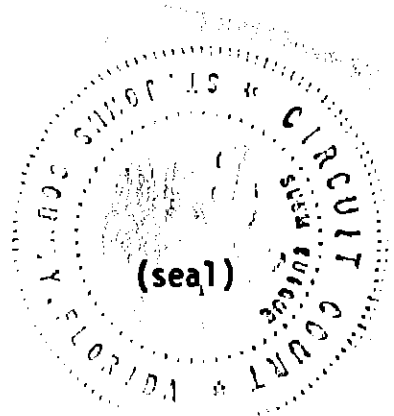

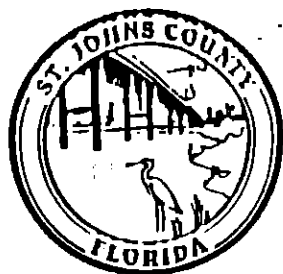


RE: Hammock Cove Drive (Presently Known as Mission Cove Drive)

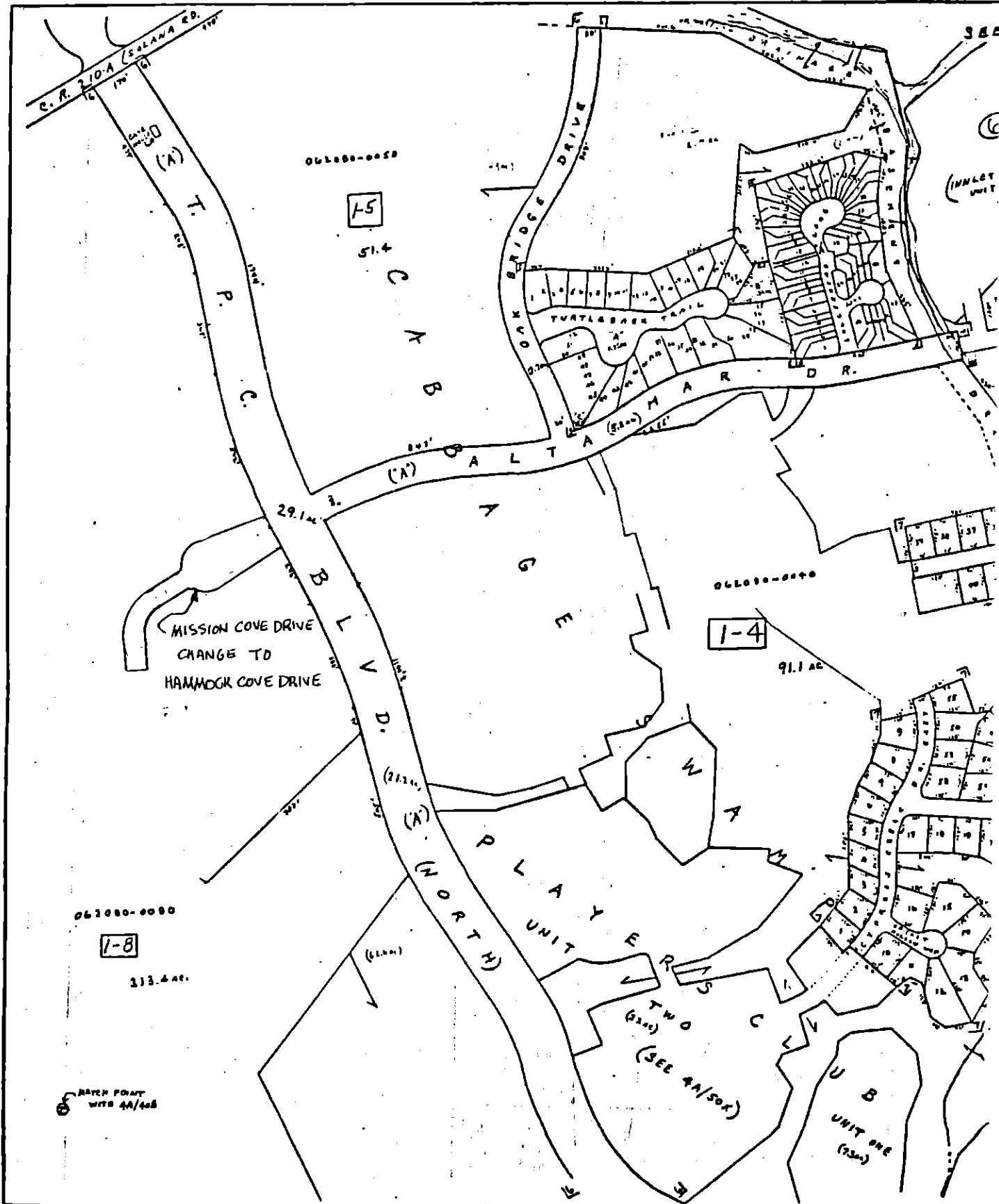
