

RESOLUTION NO. 88-186

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, AMENDING RESOLUTION NO. 88-77 FOR THE PAVING OF NATALIE ROAD UNDER THE PROVISIONS OF ORDINANCE NO. 76-21 AS AMENDED.

WHEREAS, the Board of County Commissioners of St. Johns County, Florida, considered the establishment of preliminary assessment amounts for the paving of Natalie Road at a public hearing duly noticed and passed Resolution No. 87-247; and

WHEREAS, the assessments were approved by the Board of County Commissioners on March 22, 1988, by Resolution No. 88-77; and

WHEREAS, the Notice of Lien was recorded by the Clerk of the Board in the Official Records of St. Johns County in OR777PG0733-0744; and

WHEREAS, Resolution No. 88-77 provided that the interest was to commence to accrue on July 1, 1988, but the road has not been paved to date.

NOW THEREFORE BE IT RESOLVED, by the Board of County Commissioners of St. Johns County, Florida, that the paving assessment established by Resolution No. 88-77 should not be due until such time as the road is paved.

The last sentence in Section 1 of Resolution No. 88-77 is hereby amended as follows: "The interest shall commence to accrue on January 1, 1989."

That Section 5 of Resolution No. 88-77 is hereby amended as follows: "The first installment shall become due January 1, 1989."

This resolution shall be recorded in the Official Public Records of St. Johns County, Florida.
