RESOLVED by the Board of County Commissioners of St. Johns County, Florida, this 23rd day of August, 1988.

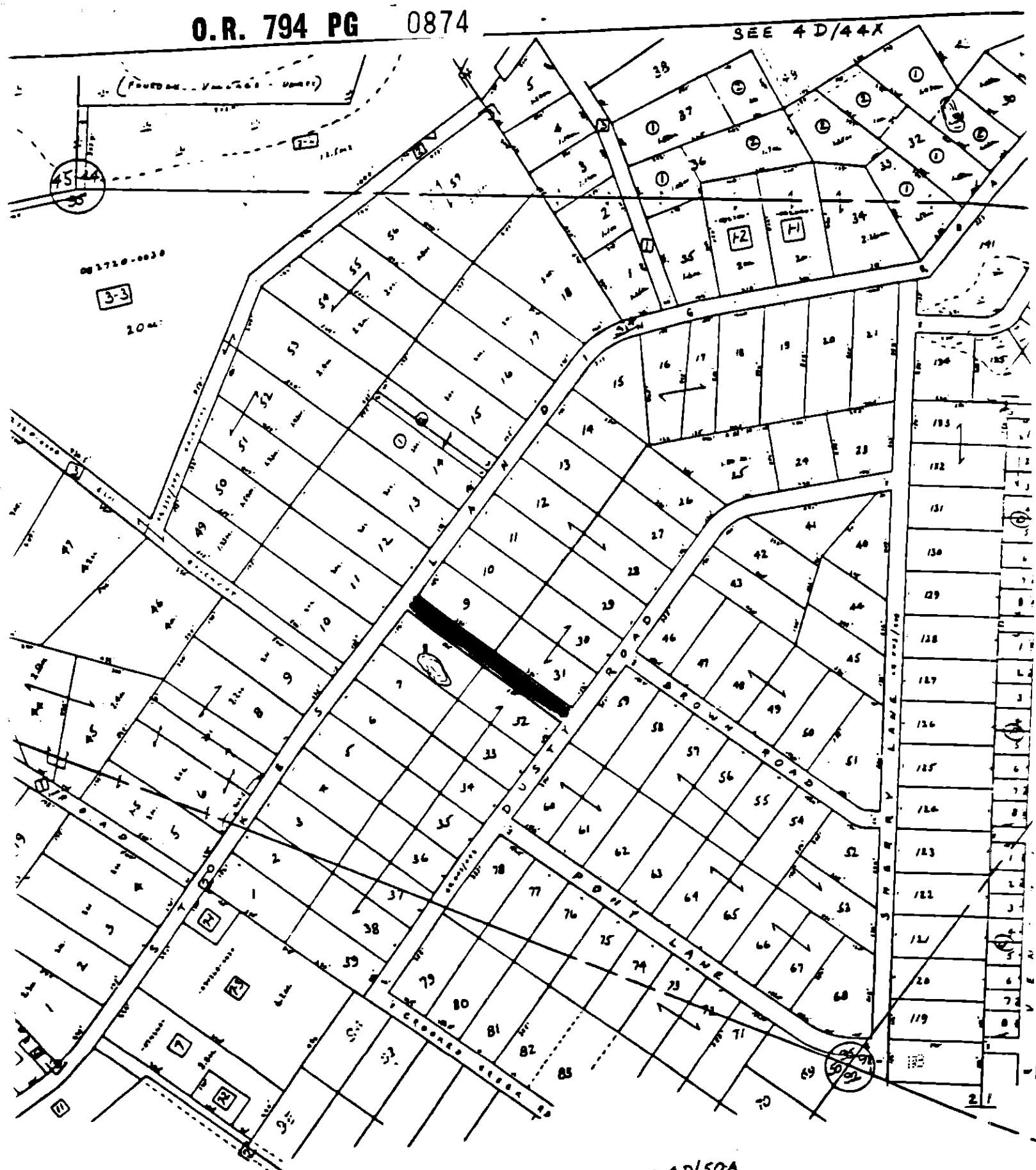
