Per our agreement the \$25.00 petition fee is being waived. The waive is in effect because the name change will help alleviate a duplication in problems.

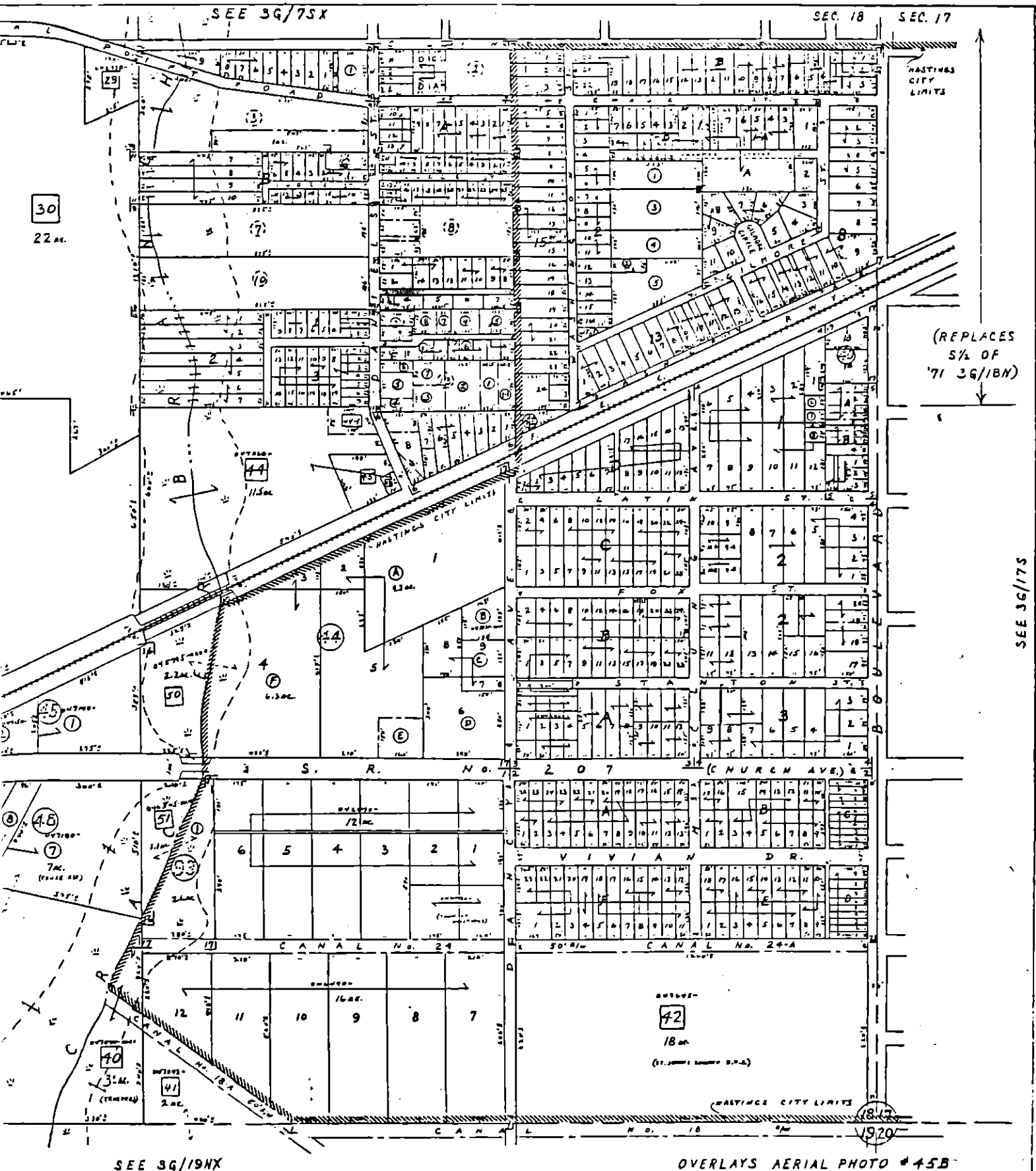
