RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS, ST. JOHNS COUNTY, FLORIDA

WHEREAS, St. Johns County Road and Bridge Department has for many years maintained those roads in the unincorporated areas of St. Johns County described in Exhibit A attached hereto with little or no documentation of record County ownership; and

WHEREAS, the County has long considered that such roads were in fact County owned roads; and

WHEREAS, County staff has been charged with the task of determining which of those roads need better record title documentation to firmly establish record County ownership; and

WHEREAS, the Board of County Commissioners has instructed staff to obtain such documentation in order to document justification for continued County maintenance of said roads;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, that the St. Johns County Road and Bridge Department will continue to maintain the roads described in Exhibit A at their present level of condition subject to the availability of funds and subject to priorities established by the Board of County Commissioners until otherwise instructed by resolution of this Board; and the Road and Bridge Department will not maintain any additional roads unless record title to such additional roads is in the name of the County and they are in compliance with Ordinance No. 86-4 as amended.
