WHEREAS, it is found to be in the public interest to rename this street in furtherance of the public health, safety and welfare;


NOW THEREFORE BE IT RESOLVED,

RESOLVED by the Board of County Commissioners of St. Johns County, Florida, this 23rd day of May, 1989.

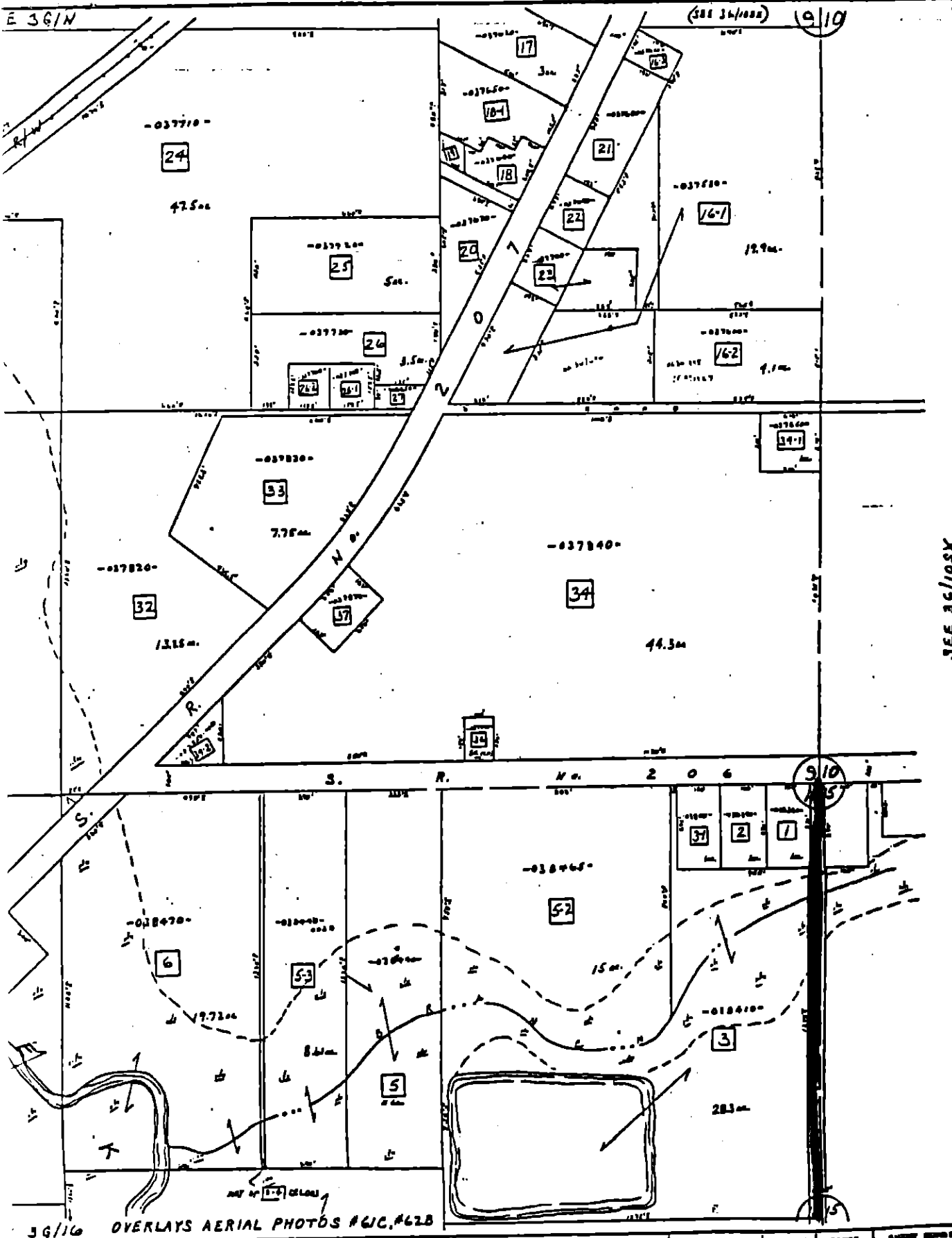
