RESOLVED by the Board of County Commissioners of St. Johns County, Florida, this 25th day of July, 1989.



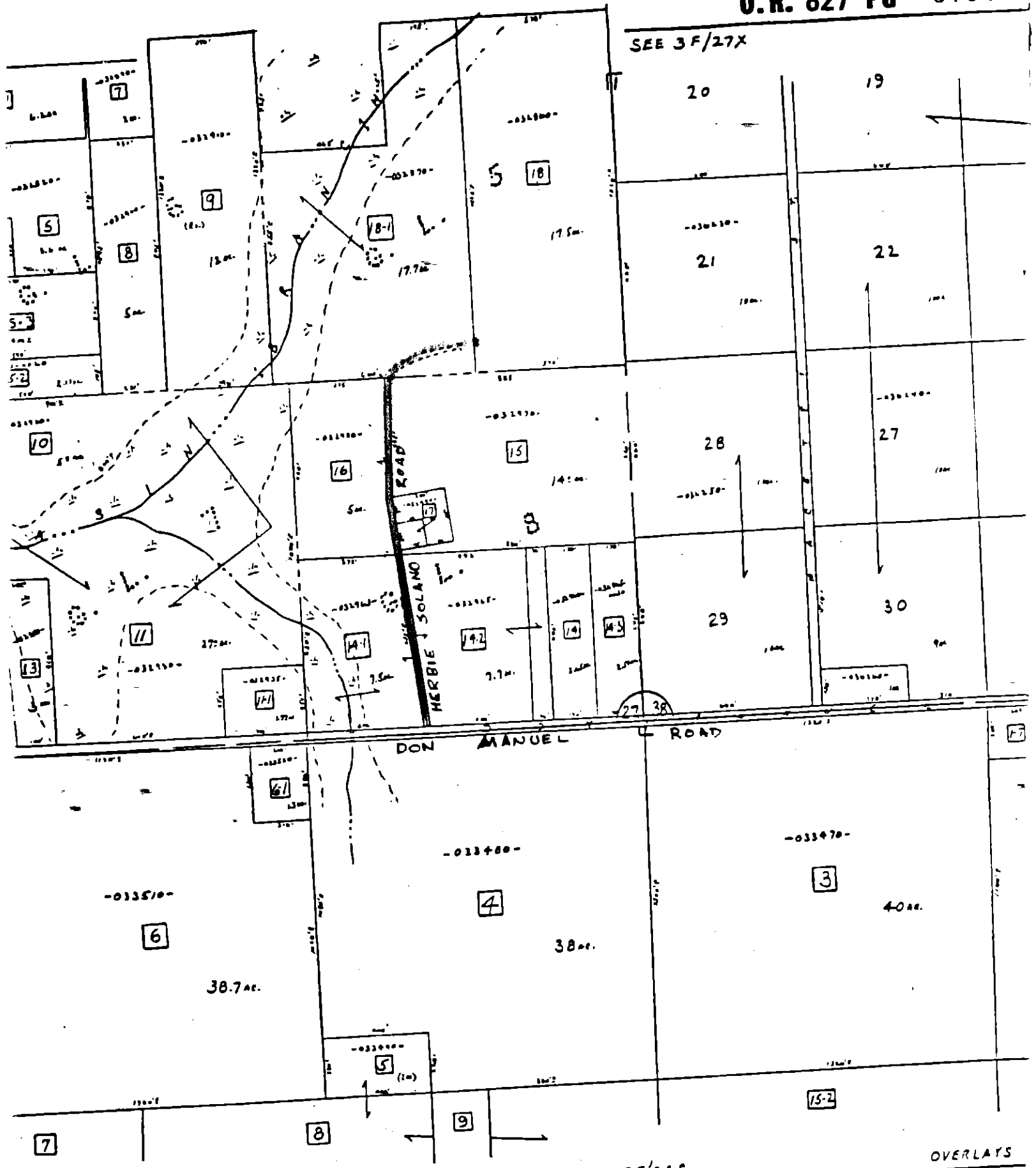
