RESOLVED by the Board of County Commissioners of St. Johns County, Florida, this 22nd day of August, 1989.

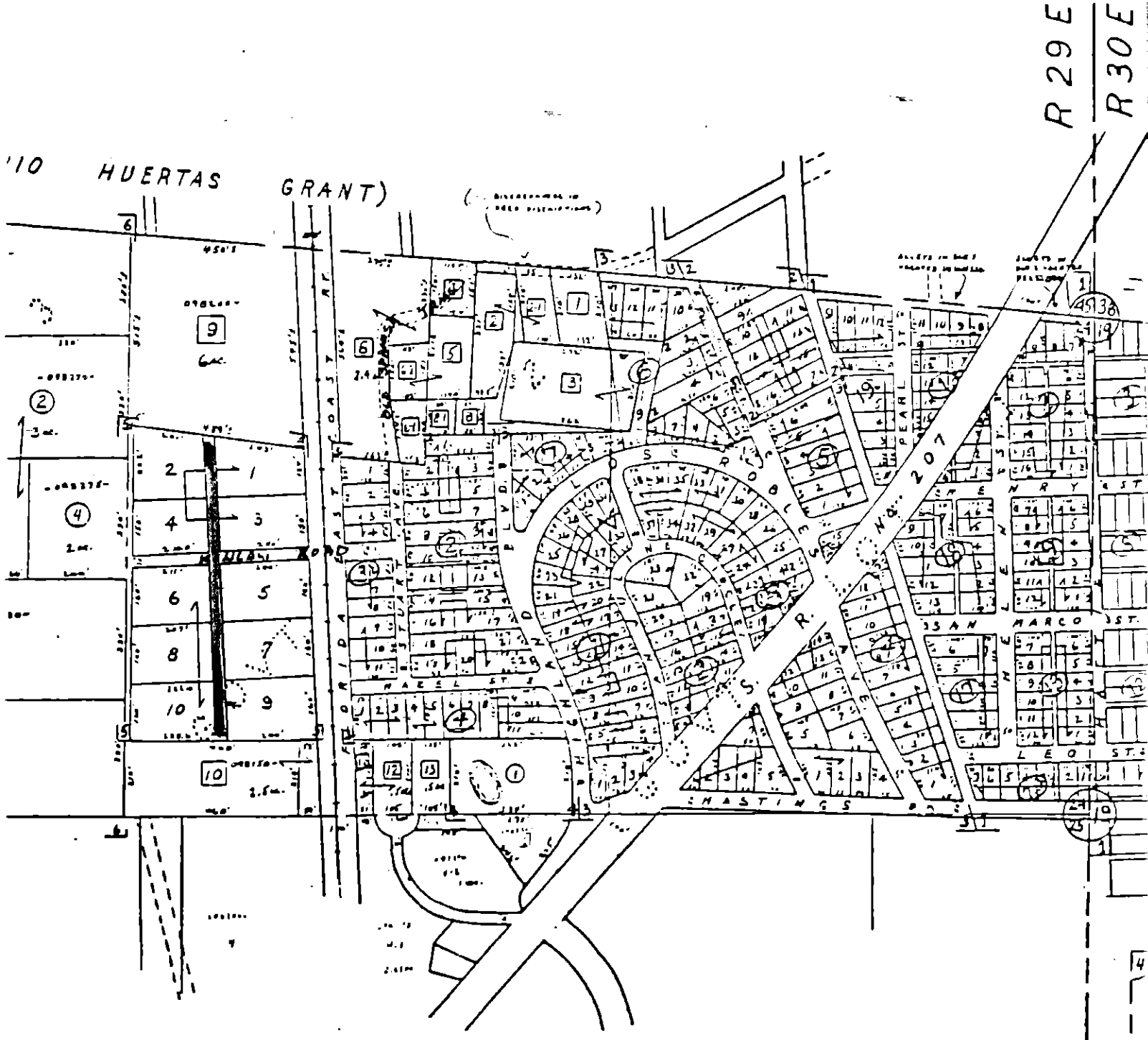
