WHEREAS, an application has been duly made to the Board of County Commissioners to rename the street known as: **ROOSEVELT BOULEVARD;**

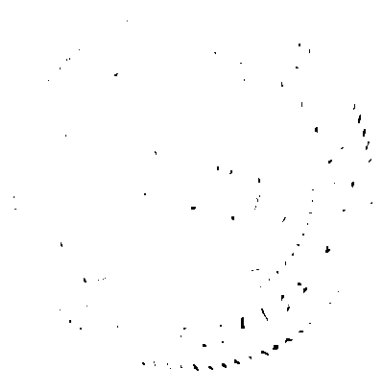
WHEREAS, it is found to be in the public interest to rename this street in furtherance of the public health, safety and welfare,

RESOLVED by the Board of County Commissioners of St. Johns County, Florida, this 22nd day of August, 1989.

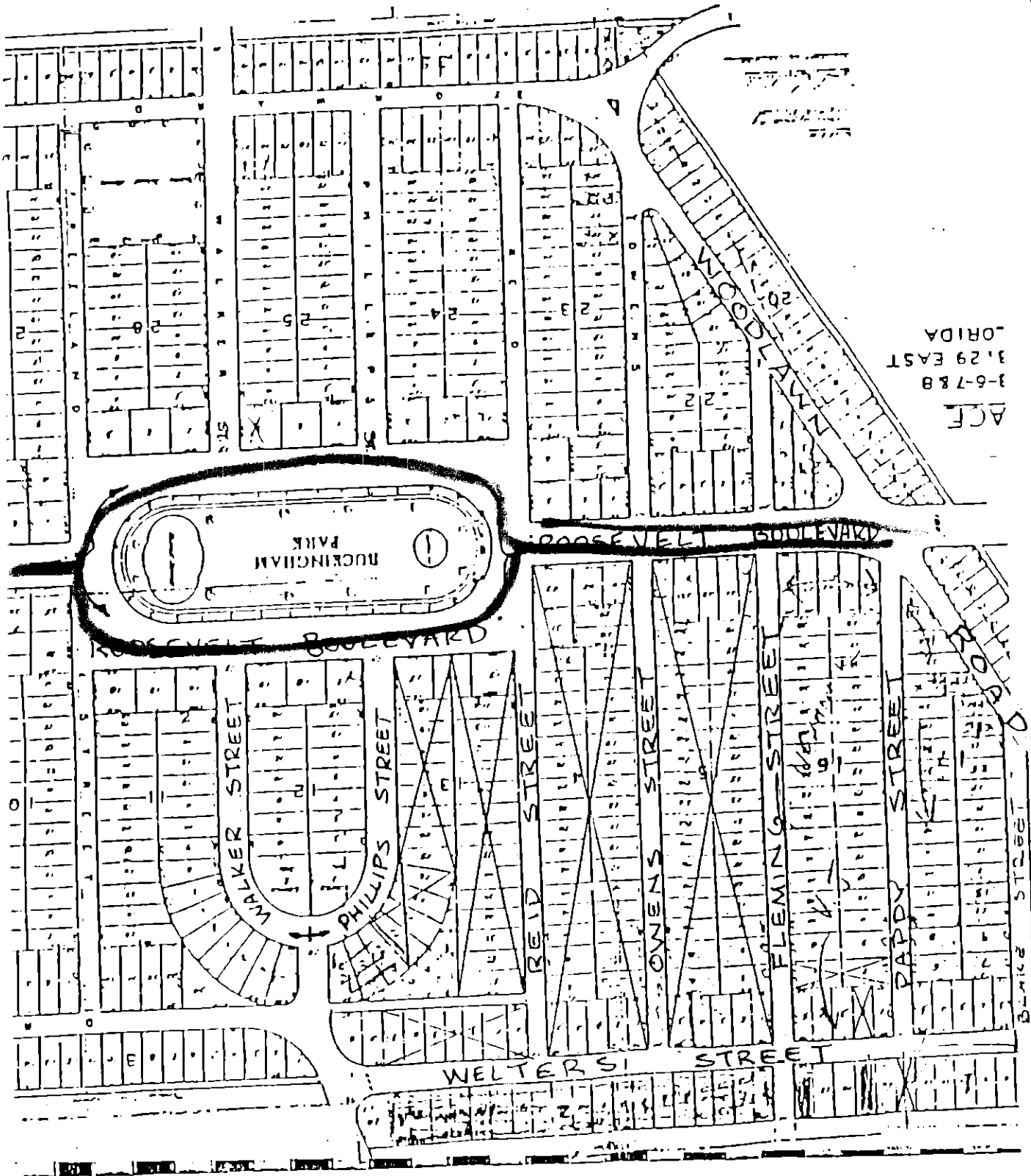
