NOW THEREFORE BE IT RESOLVED,

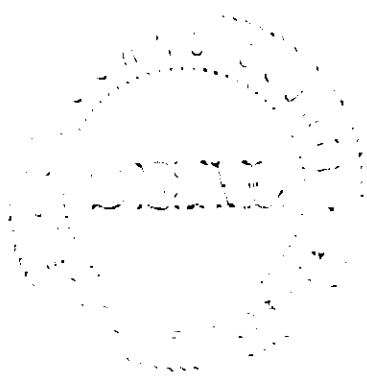
1. That the said street known as **REMINGTON AVENUE**, is hereby renamed to **MYSTICAL WAY**, and shall hereafter be known by said new name.
