RESOLVED by the Board of County Commissioners of St. Johns County, Florida, this 24th day of October, 1989.

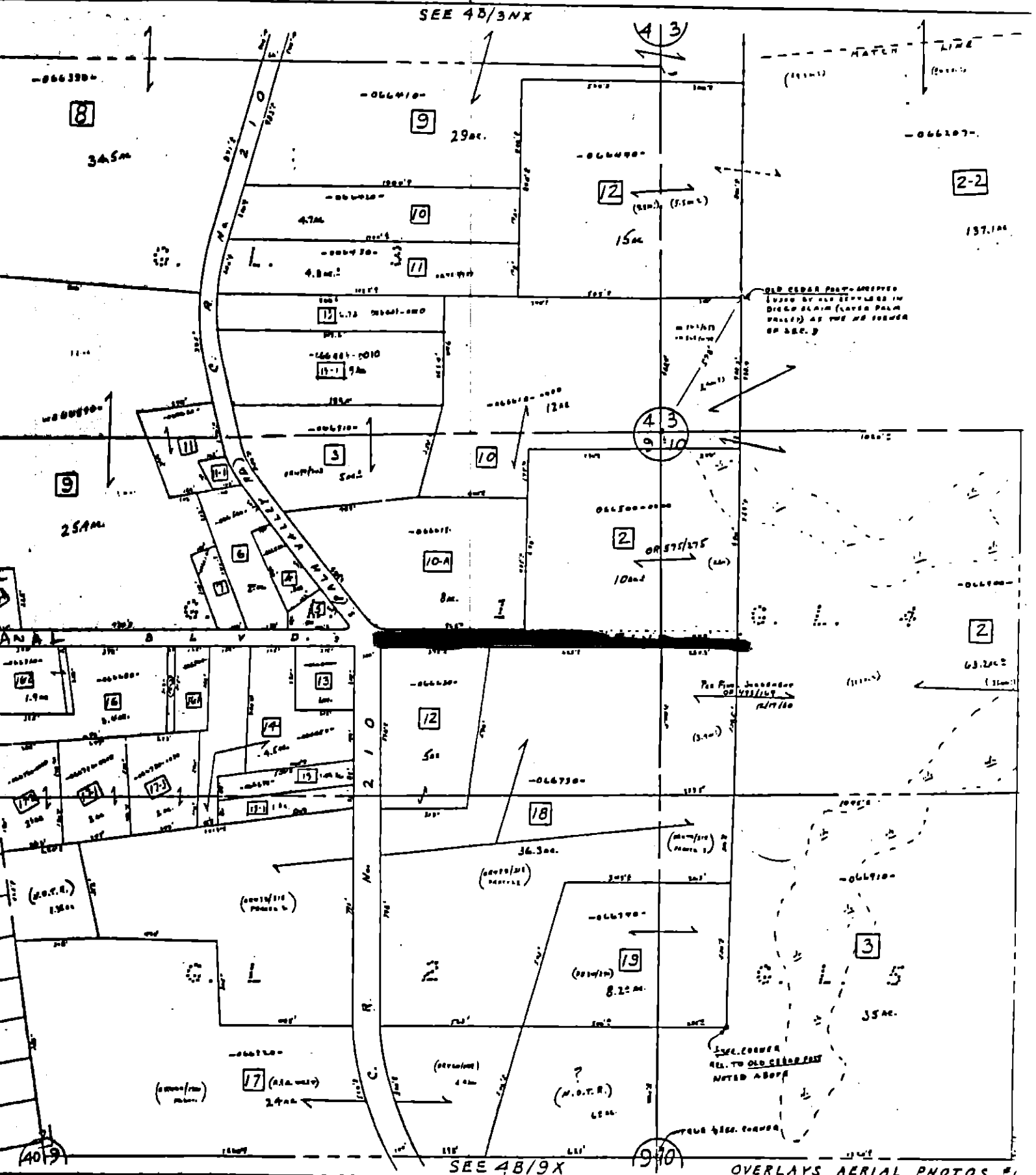

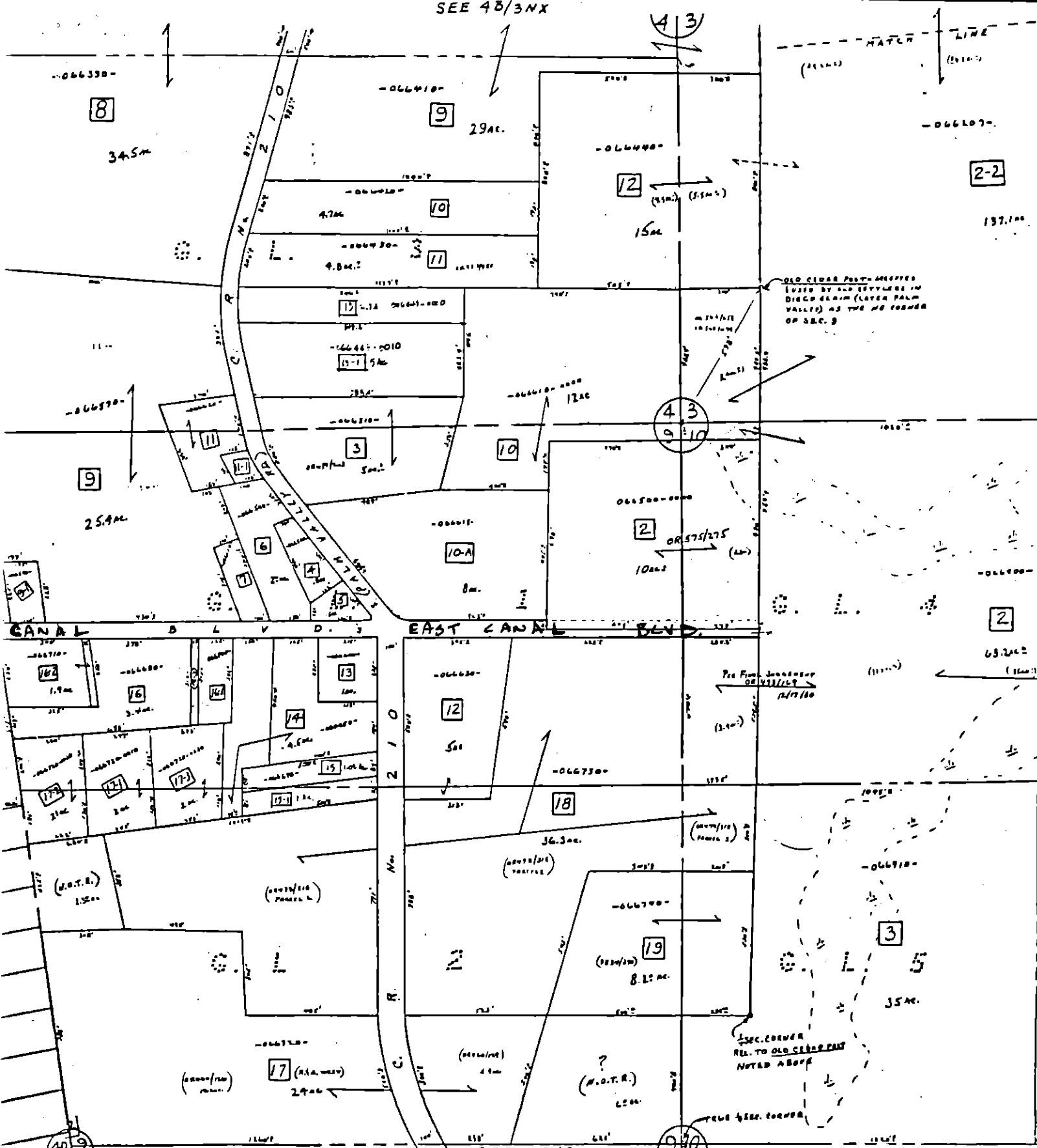
