WHEREAS, an application has been duly made to the Board of County Commissioners to rename the street known as: **BERT FLOYD ROAD;**

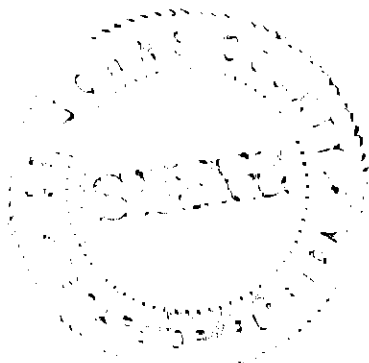
WHEREAS, it is found to be in the public interest to rename this street in furtherance of the public health, safety and welfare;

RESOLVED by the Board of County Commissioners of St. Johns County, Florida, this 24th day of October, 1989.

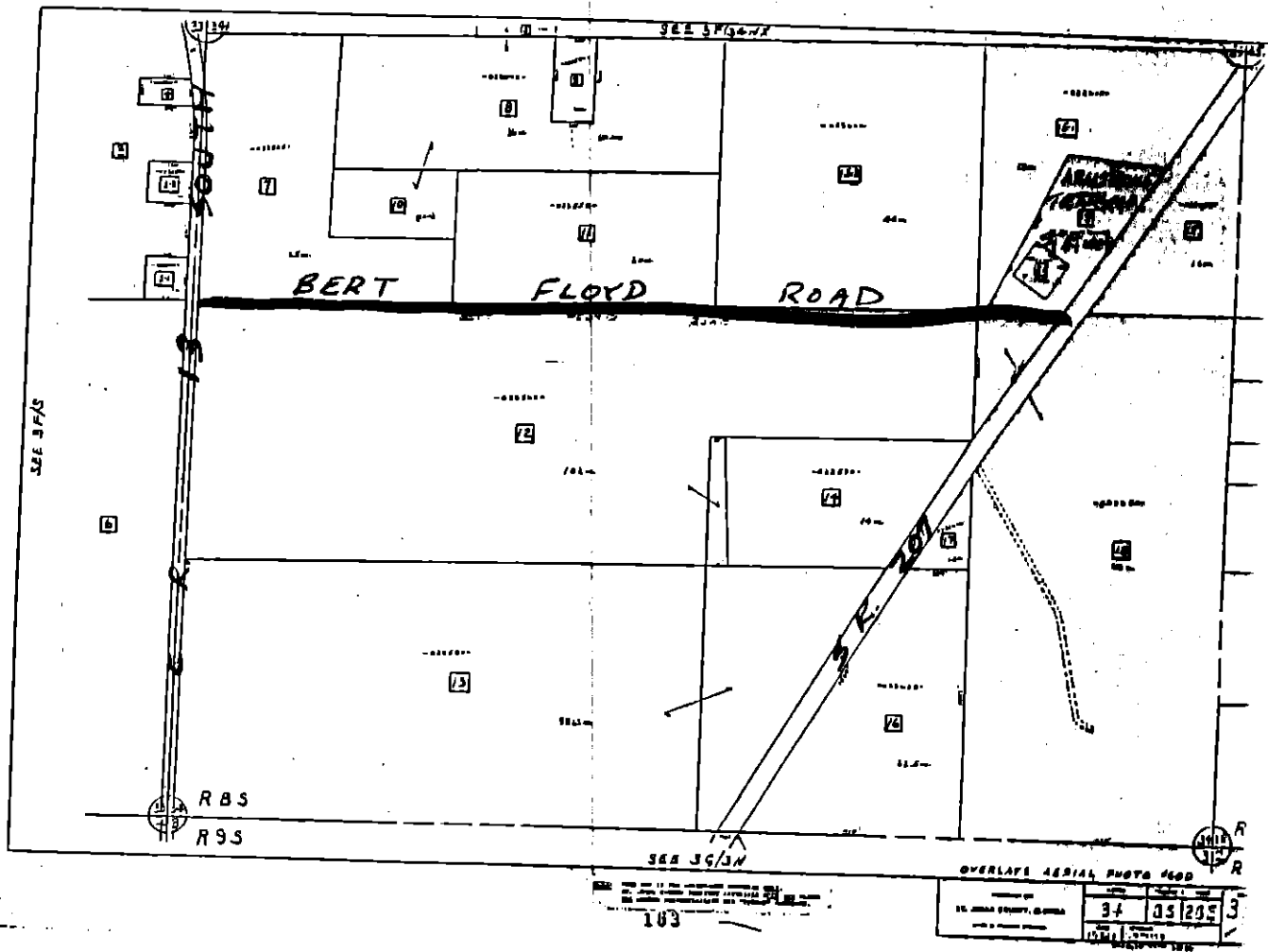
