RESOLUTION NO. 89-25

WHEREAS, the Board of County Commissioners of St. Johns County, Florida, by Resolution #85-3 adopted January 8, 1985, appointed Fred Brinkhoff as a member of the St. Johns County Industrial Development Authority for a term of four years, and
