WHEREAS, an application has been duly made to the Board of County Commissioners to rename the street known as: **NO NAME ROAD;**

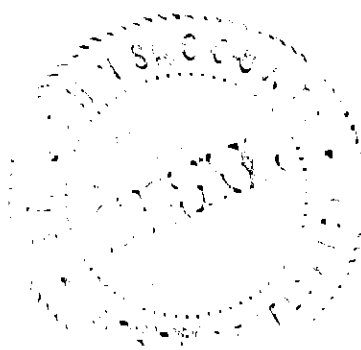
WHEREAS, it is found to be in the public interest to rename this street in furtherance of the public health, safety and welfare;

NOW THEREFORE BE IT RESOLVED,


1. That the said street known as **NO NAME ROAD**, is hereby renamed to **BUSINESS WAY**, and shall hereafter be known by said new name.

2. That the application fee in the amount of \$25.00 for the renaming of this street is not waived.


