WHEREAS, it is found to be in the public interest to rename this street in furtherance of the public health, safety and welfare;


NOW THEREFORE BE IT RESOLVED,


2. That the application fee in the amount of \$25.00 for the renaming of this street is not waived.

RESOLVED by the Board of County Commissioners of St. Johns County, Florida, this 14th day of November, 1989.

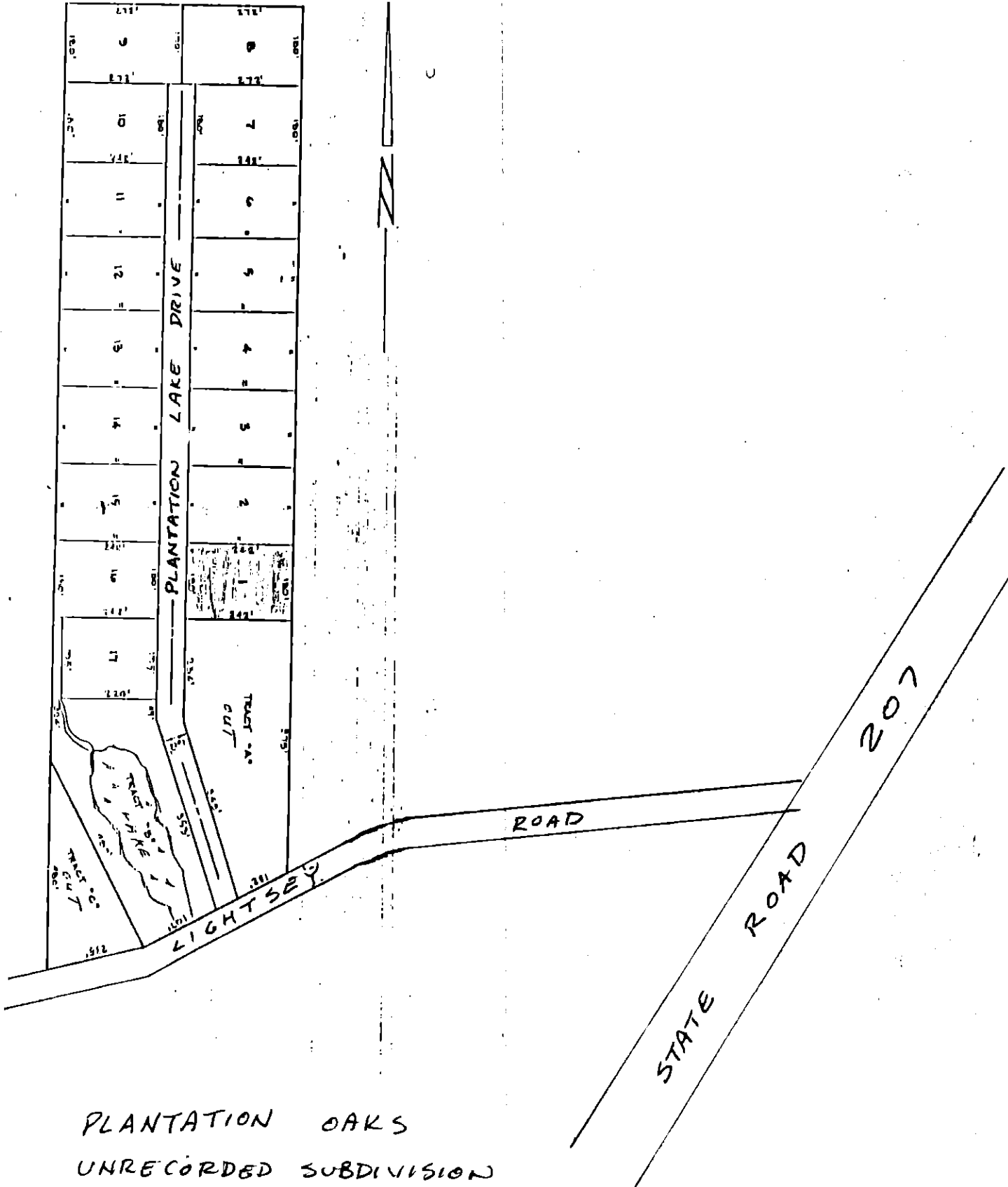
