WHEREAS, an application has been duly made to the Board of County Commissioners to rename the street known as: **WELTERS STREET**;

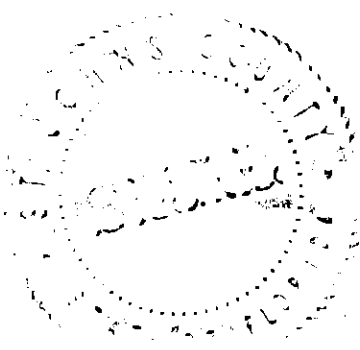
WHEREAS, it is found to be in the public interest to rename this street in furtherance of the public health, safety and welfare;

2. That the application fee in the amount of \$25.00 for the renaming of this street is not waived.


