### GRANT OF SEWER EASEMENT

THIS GRANT, made as of the 24 day of November, 1989, between SPANISH TRACE OCEAN CLUB, INC., a Florida corporation (hereinafter "Grantor"), and COUNTY OF ST. JOHNS, a political subdivision of the State of Florida (hereinafter "Grantee").

## WITNESSETH

That for and in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration paid to Grantor by Grantee, the receipt and sufficiency of which is hereby acknowledged, Grantor hereby gives, grants, dedicates, releases and quit claims to Grantee, its successors and assigns forever, a and quit claims to Grantee, its successors and assigns lorever, a non-exclusive easement over the Easement Parcel hereinafter described for the purpose of constructing, operating, laying, maintaining, improving and/or repairing lines, pipes, pumps and appurtenant facilities relating to sewage and waste transmission and disposal. This Grant of Sewer Easement shall be on, along, over, through, across and under the parcel of land located in St. Johns County, Florida (the "Easement Parcel") as specifically described on Exhibit A attached hereto and made a part hereof.

TOGETHER with the right to the Grantee, its successors and assigns, of ingress and egress, to and over the Easement Parcel, and for doing anything necessary or useful or convenient for the enjoyment of the easement herein granted.

PROVIDED, however, that Grantor retains the right to use the Easement Parcel for landscaping, surface parking, driveways and such other uses that will not interfere with the rights granted hereby to Grantee.

PROVIDED FURTHER, however, that by acceptance hereof, grantee does release, remise, quit claim and abandon unto Grantor any and all right, title or interest, Grantee may have in or to any and all right, title or interest, Grantee may have in or to any other property of Grantor not included within the Easement any other property of Grantor not included within the Easement Parcel which is, was or has been used for sewage and waste transmission and disposal; it being the intent of Grantor and Grantee that the Easement Parcel shall replace and be substituted for any previously existing rights or easements of Grantee in, to or on Grantor's property for sewage and waste transmission and disposal. disposal.
