RESOLUTION ON GRANT ASSISTANCE UNDER THE FLORIDA INLAND NAVIGATION DISTRICT GRANTS TO LOCAL GOVERNMENTS PROGRAM

and the State of Florida:
Project Title <u>St. Augustine South/Butler Park West Dredging</u>
Total Estimated Cost \$ 153,100 One Hundred Fifty-Three Thousand One Hundred
Brief Description of Project: This project will involve the maintenance dredging of 10,000 cubic yards of material from the access channels exclusively serving two (2) public boat ramps, one at St. Augustine South and one at Butler Park West, both located on the Intercoastal Waterway.
AND, Florida Inland Navigation District financial assistance is required for program mentioned above,
NOW THEREFORE, be it resolved by the Board of County Commissioners of St. Johns County
that the project described above be authorized,
AND, be it further resolved that said <u>st. Johns County Administrator</u>
make application to the Florida Inland Navigation District in the amount of \$76,550.00
50% of the actual cost of the project in behalf of said st. Johns County
AND, be it further resolved by the Board of County Commissioners of St. Johns County
that it certifies to the following:
1. That it will accept the terms and conditions set forth in the FIND
Grants Guidelines and which will be a part of the Project Agreement for any

grant awarded under the attached proposal.

- 2. That it is in complete accord with the attached proposal and that it will carry out the Program in the manner described in the proposal and any plans and specifications attached thereto unless prior approval for any change has been received from the District.
- 3. That it has the ability and intention to finance its share of the cost of the project and that the project will be operated and maintained at the expense of said <u>St. Johns County</u> for public use.
- 4. That it will not discriminate against any person on the basis of race, color or national origin in the use of any property or faculity acquired or developed pursuant to this proposal, and shall comply with the terms and intent of the Title VI of the Civil Rights Act of 1964, P. L. 88-352 (1964) and design and construct all facilities to comply fully with statutes relating to accessibility by handicapped persons as well as other federal, state and local laws, rules and requirements.
- 5. That it will maintain adequate financial records on the proposed project to substantiate claims for reimbursement.
- 6. That it will make available to FIND, a post-audit of expenses incurred on the project prior to, or in conjunction with, request for the final 10% of the funding agreed to by FIND.
