NOW THEREFORE BE IT RESOLVED

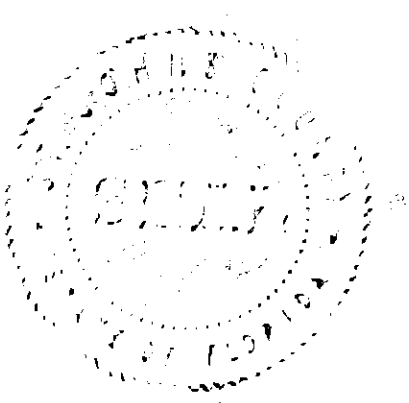
1. That the said street known as **NO NAME ROAD**, is hereby renamed to , **ARBOR CLUB DRIVE** and shall hereafter be known by said new name.

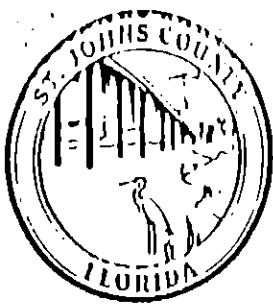
