A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, ESTABLISHING A SCHEDULE OF FEES FOR CERTAIN SERVICES AND AMENDING FEES FOR CERTAIN SERVICES RENDERED BY THE COUNTY IN CONNECTION WITH ZONING AND LAND DEVELOPMENT; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Board of County Commissioners of St. Johns County, Florida, is authorized to establish and collect fees and charges for certain services as per St. Johns County Ordinance No. 73-1, 73-4, 73-5, 74-3, 77-6, (Section 11-3), and Ordinance No. 78-38, and Ordinance No. 86-79 of the St. Johns County Zoning Codes and St. Johns County Subdivisoion Regulations; and,

WHEREAS, the attached schedule of fees and charges has been examined and represents a reasonable reimbursement to the County for its actual costs in providing the services.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA:

Section 1: Approval of Fees and Charges

The schedule of fees and charges which is attached hereto and made a part hereof as Exhibit "A" is hereby adopted. Unless stated otherwise on Exhibit "A", such fees and charges shall be paid upon submittal of the application.

Section 2: Effective Date

This resolution shall take effect on the <u>lst</u> day of <u>October</u>, 1990.

<u>Section 3</u>: The fees and charges shall be paid to and collected by the Planning and Zoning Department for deposit in the General Fund and shall be non-refundable.

<u>Section 4:</u> Those fees and charges previously established by St. Johns County that are in conflict with Exhibit "A" are hereby repealed.
