RESOLVED by the Board of County Commissioners of St. Johns County, Florida, this 11th day of September, 1990.

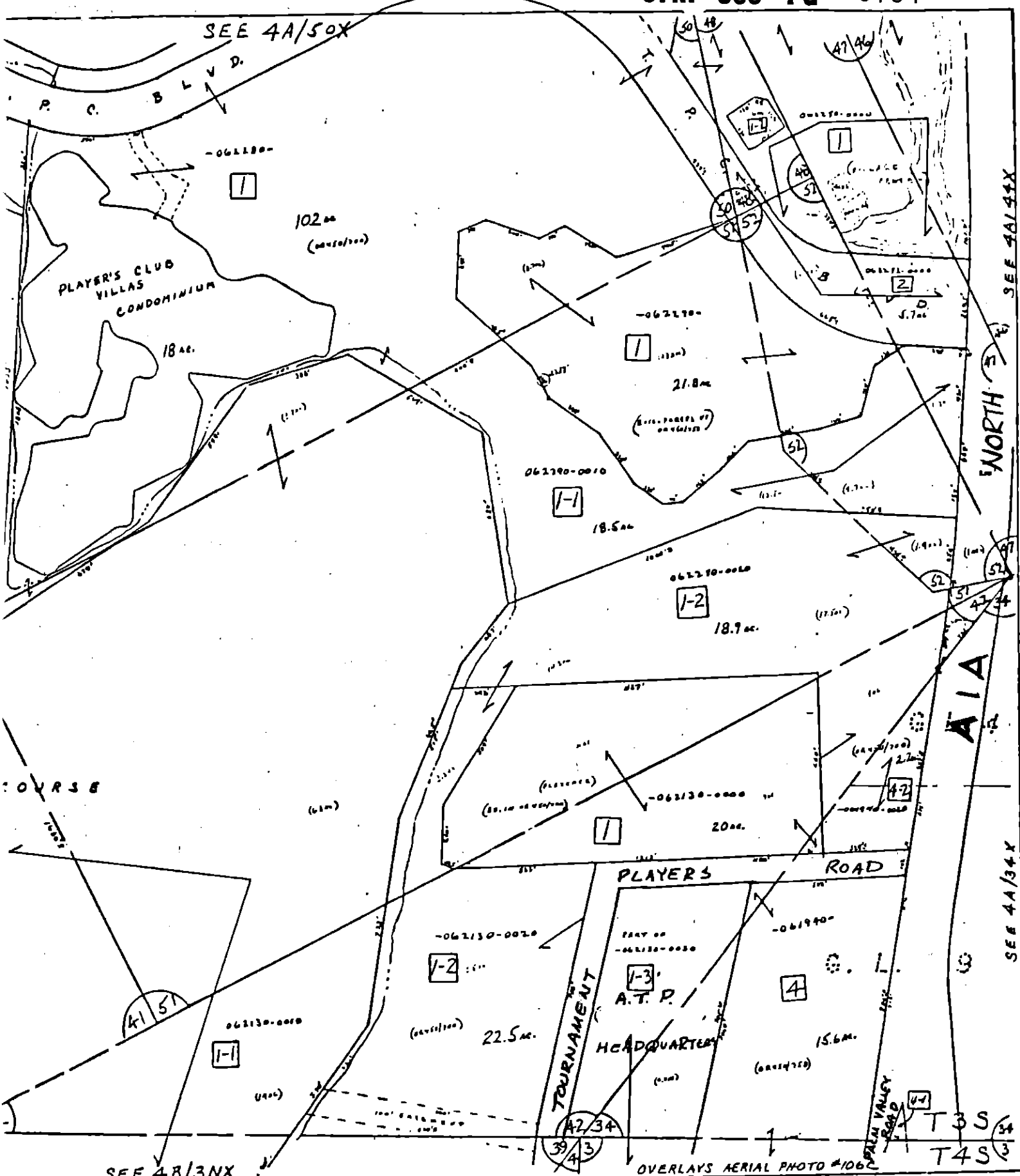

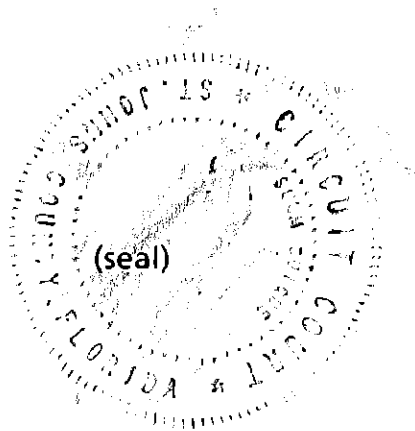

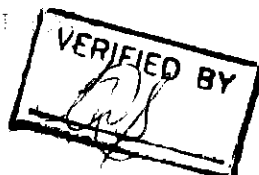
