RESOLVED by the Board of County Commissioners of St. Johns County, Florida, this 25th day of September, 1990.

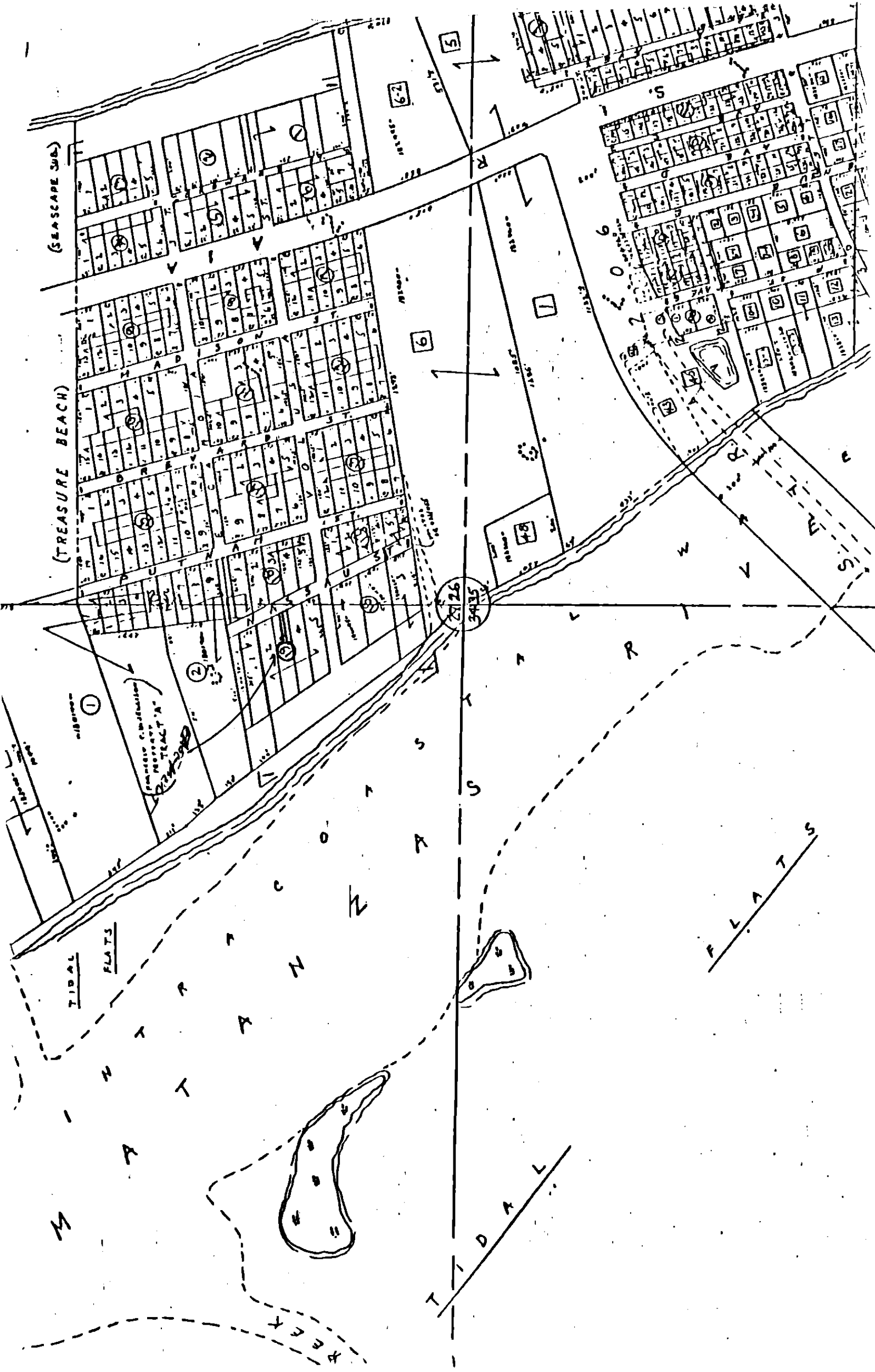

30 Foot Easement for Egress, Egress and Utilities:

A portion of Lots 2, 3 and 4, Block 19, Map of Part of Ocean Grove as recorded in Mapbook 11, page 95, Public Records of St. Johns County, Florida and more particularly described as follows: For a Point of Commencement use the Northeast corner of said Lot 2, said corner lying on the westerly right-of-way line of Nassau Street (a 40 foot right-of-way as per referenced subdivision); thence South 27°36'00" East 73.32 feet along said westerly line to the Point of Beginning of said easement; thence continue South 27°36'00" East along said line 31.38 feet; thence South 80°01'00" West, 104.63 feet to a point on a curve, said curve non-tangent to the last referenced line and having a radius of 30 feet, a delta of 299°45'53" and an arc of 156.96 feet thence following the arc of said curve 156.96 feet to a point; said points bearing and distance from the Point of Beginning being South 80°01'00" West and 95.27 feet; thence North 80°01'00" East, 95.27 feet to the Point of Beginning. Said easement contains 40.1539 acres.

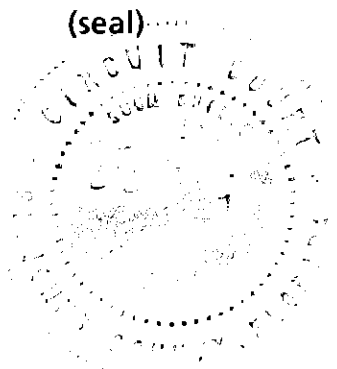

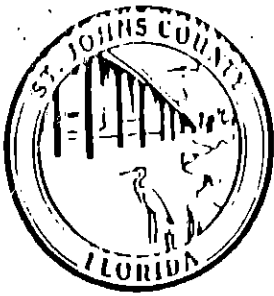

INSTRUCTIONS FOR ROAD NAMING PETITION

1. OBTAIN SIGNATURES OF AT LEAST 51% OF THE PROPERTY OWNERS ON THE STREET TO BE NAMED. EACH PROPERTY OWNER MUST LEGIBLY PRINT OR TYPE HIS/HER NAME BELOW THE RESPECTIVE SIGNATURE AND INCLUDE EACH OWNER'S STREET ADDRESS.
2. WHEN THE REQUIRED SIGNATURES HAVE BEEN OBTAINED, ONE SPOKESPERSON SHOULD PROVIDE HIS/HER ADDRESS AND PHONE NUMBER AS A CONTACT PERSON ON THE SUBJECT OF THE NAME CHANGE.
3. THE DESIRED NAME CHOICES (at least three should be submitted) SHOULD BE CHECKED WITH THE 911 TASK FORCE/OFFICE OF 911 COORDINATOR OR WITH STREET NAME INDEXES TO BE POSTED IN ALL ST. JOHNS COUNTY PUBLIC LIBRARIES. NO NAME DUPLICATIONS WILL BE ALLOWED, REGARDLESS OF WHETHER THE IDENTIFIER IS A STREET, ROAD, WAY, TERRACE, ETC.
4. THE COMPLETED PETITION AND A CHECK FOR THE \$25.00 FILING FEE (NON-REFUNDABLE) SHOULD BE MAILED OR DELIVERED TO THE BUILDING DEPARTMENT, ST. JOHNS COUNTY, FLORIDA.
5. AFTER REVIEW AND REFERRAL TO THE ST. JOHNS BOARD OF COUNTY COMMISSIONERS, THE CONTACT PERSON WILL BE NOTIFIED BY COUNTY PERSONNEL. IT WILL BE THE RESPONSIBILITY OF THE CONTACT PERSON TO NOTIFY ALL PROPERTY OWNERS OF THE OUTCOME OF THE PETITION.
6. WHEN A NEW NAME HAS BEEN APPROVED BY THE COUNTY COMMISSIONERS, THE APPROPRIATE NUMBER OF STREET SIGNS (TO BE DETERMINED BY COUNTY PERSONNEL) WILL BE PREPARED.

SIGNS WILL BE PREPARED WHEN PAYMENT FROM PROPERTY OWNERS HAS BEEN RECEIVED. ALL SIGN PAYMENTS MUST BE RECEIVED BEFORE ANY SIGNS ARE RELEASED FOR INSTALLATION. CHARGES REFERRED TO HERE DO NOT INCLUDE COSTS FOR POLES OR INSTALLATION.
