

- 2. WHEN THE REQUIRED SIGNATURES HAVE BEEN OBTAINED, ONE SPOKES-PERSON SHOULD PROVIDE HIS/HER ADDRESS AND PHONE NUMBER AS A CONTACT PERSON ON THE SUBJECT OF THE NAME CHANGE.
- 3. THE DESIRED NAME CHOICES (at least three should be submitted) SHOULD BE CHECKED WITH THE 911 TASK FORCE/OFFICE OF 911 COORDINATOR OR WITH STREET NAME INDEXES TO BE POSTED IN ALL ST. JOHNS COUNTY PUBLIC LIBRARIES. NO NAME DUPLICATIONS WILL BE ALLOWED, REGARDLESS OF WHETHER THE IDENTIFIER IS A STEET, ROAD, WAY, TERRACE, ETC.
- 4. THE CUMPLETED PETITION AND A CHECK FOR THE \$25.00 FILING FEE (NON-REFUNDABLE) SHOULD BE MAILED OR DELIVERED TO THE BUILDING DEPARTMENT, ST. JOHNS COUNTY, FLORIDA.
- 5. OFTER REVIEW AND REFERRAL TO THE ST. JOHNS BOARD OF COUNTY COMMISSIONERS, THE CONTACT PERSON WILL BE NOTIFIED BY COUNTY PERSONNEL. IT WILL BE THE RESPONSIBLITY OF THE CONTACT PERSON TO NOTIFY ALL PROPERTY OWNERS OF THE OUTCOME OF THE PETITION.
