RESOLUTION NO. 90-172

A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA AMENDING RESOLUTION 90-124 WHICH STATED THE BOARD'S INTENT TO USE THE UNIFORM METHOD OF COLLECTING NON-AD VALOREM ASSESSMENTS (FLORIDA STATUTES 197.3632) FOR THE COLLECTION OF THE FIRE PROTECTION AND THE SEWAGE COLLECTION SPECIAL ASSESSMENTS LEVIED PURSUANT TO ST. JOHNS COUNTY ORDINANCE 90-16 TO FUND A PORTION OF THE COSTS, INCLUDING DEBT SERVICE, OF THE COUNTY'S WATER AND SEWER PROJECT 1990A AS DESCRIBED IN SAID ORDINANCE; THE ASSESSED PROPERTIES BEING THOSE IMPROVEMENTS AND/OR LANDS LOCATED WITHIN THE I-95/SR-16 MUNICIPAL SERVICE BENEFIT UNIT IN THE UNINCORPORATED AREA OF ST. JOHNS COUNTY, FLORIDA THAT WILL SPECIALLY BENEFIT FROM (i) THE ACQUISITION AND CONSTRUCTION OF THE SEWAGE COLLECTION LINES AROUND THE I-95/SR-16 INTERCHANGE AND/OR (ii) THE ACQUISITION AND CONSTRUCTION OF THE FIRE PROTECTION CAPACITY OF THE WATER LINES AND THE FIRE HYDRANTS AROUND THE I-95/SR-16 INTERCHANGE AND ALONG SR-16. THIS AMENDMENT CORRECTS AN ERROR IN THE LEGAL DESCRIPTION OF PARCEL 6 OF EXHIBIT B, BEING ONE OF THE PARCELS UPON WHICH SEWAGE COLLECTION NON AD VALOREM SPECIAL ASSESSMENTS ARE ASSESSED.

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA that whereas the legal description set forth as parcel 6 in Exhibit B to St. Johns County Resolution 90-124 incorrectly described a parcel of land upon which a County sewage collection non ad valorem special assessment is assessed, St. Johns County Resolution 90-124 is hereby amended by deleting the legal description described in parcel 6 from Exhibit B of the resolution and by adding and substituting the following in its stead:

PARCEL 6

THE WEST 19 FEET OF LOT 2 AND ALL OF LOTS 3, 4, 5 AND 6, TOGETHER WITH THE EAST 19 FEET OF LOT 7, OF STAGE COACH MANOR SUBDIVISION FOR THE PLAT OF RECORD RECORDED IN MAP BOOK 14 PAGE 89 OF THE PUBLIC RECORDS OF ST. JOHNS COUNTY, FLORIDA.
