

RESOLUTION No. 90-224

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY AUTHORIZING COUNTY PERSONNEL TO EXECUTE PURCHASE ORDERS WITHOUT BIDS FOR CERTAIN GOODS, SUPPLIES, EQUIPMENT AND MATERIALS DESCRIBED IN ST. JOHNS COUNTY JAIL EXPANSION 90-69 CONTRACT WITH FOLEY AND ASSOCIATES CONSTRUCTION COMPANY, INC.

WHEREAS, the Board of County Commissioners advertised for, and received bids for the construction of the St. Johns County Jail Expansion and,

WHEREAS, Foley and Associates Construction Company, Inc., was awarded the construction contract dated December 4, 1990.

WHEREAS, the bid documents and the contract provided for the Contractor to prepare purchase orders for equipment, materials and supplies to be purchased directly by the County to enable such purchases to be exempt from the Florida Sales Tax without the County incurring undue risks concerning timely delivery of the items to the trade contractors performing the construction and installation of the work described in the construction contract; and,

WHEREAS, advertising once each week for two weeks for bids for certain materials, equipment and supplies described in the previously advertised and awarded construction contract would be redundant and would cause chaos in the scheduling of construction and unduly delay completion of the project,

NOW THEREFORE BE IT RESOLVED by the Board of County Commissioners of St. Johns County, Florida, this 4th day of December 1990 as follows:

- SECTION 1. County personnel are hereby authorized to sign purchase orders prepared by Foley and Associates Construction Company, Inc. pursuant to its contract with the County dated December 4, 1990 for supplies, materials and equipment for the St. Johns County Jail Expansion facilities and such supplies, materials and equipment may be purchased and paid for without advertising, or County bids.
- SECTION 2. Such supplies, materials and equipment are already included in the lump sum contract for the St. Johns County Jail Expansion and the county will receive a credit for all sales tax and discount savings up to the amount of \$175,000.00, after which the savings accrues to the Contractor. This arrangement is to motivate the contractor to save the County as much as possible.
- SECTION 3. Such supplies, materials and equipment were included as part of the previously advertised request for bids for the construction of the St. Johns County Jail Expansion.

SECTION 4. Such supplies, materials and equipment cannot be obtained in sufficient time if bids, public notice and advertisement are again required.
