NOW THEREFORE BE IT RESOLVED

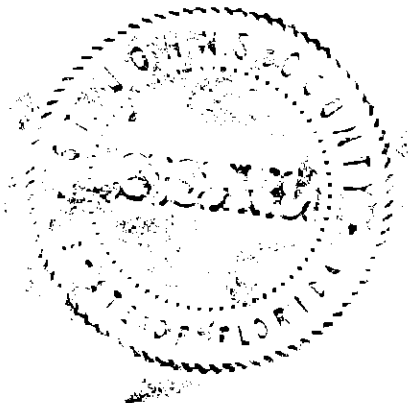

RESOLVED by the Board of County Commissioners of St. Johns County, Florida, this 13th day of February, 1990.

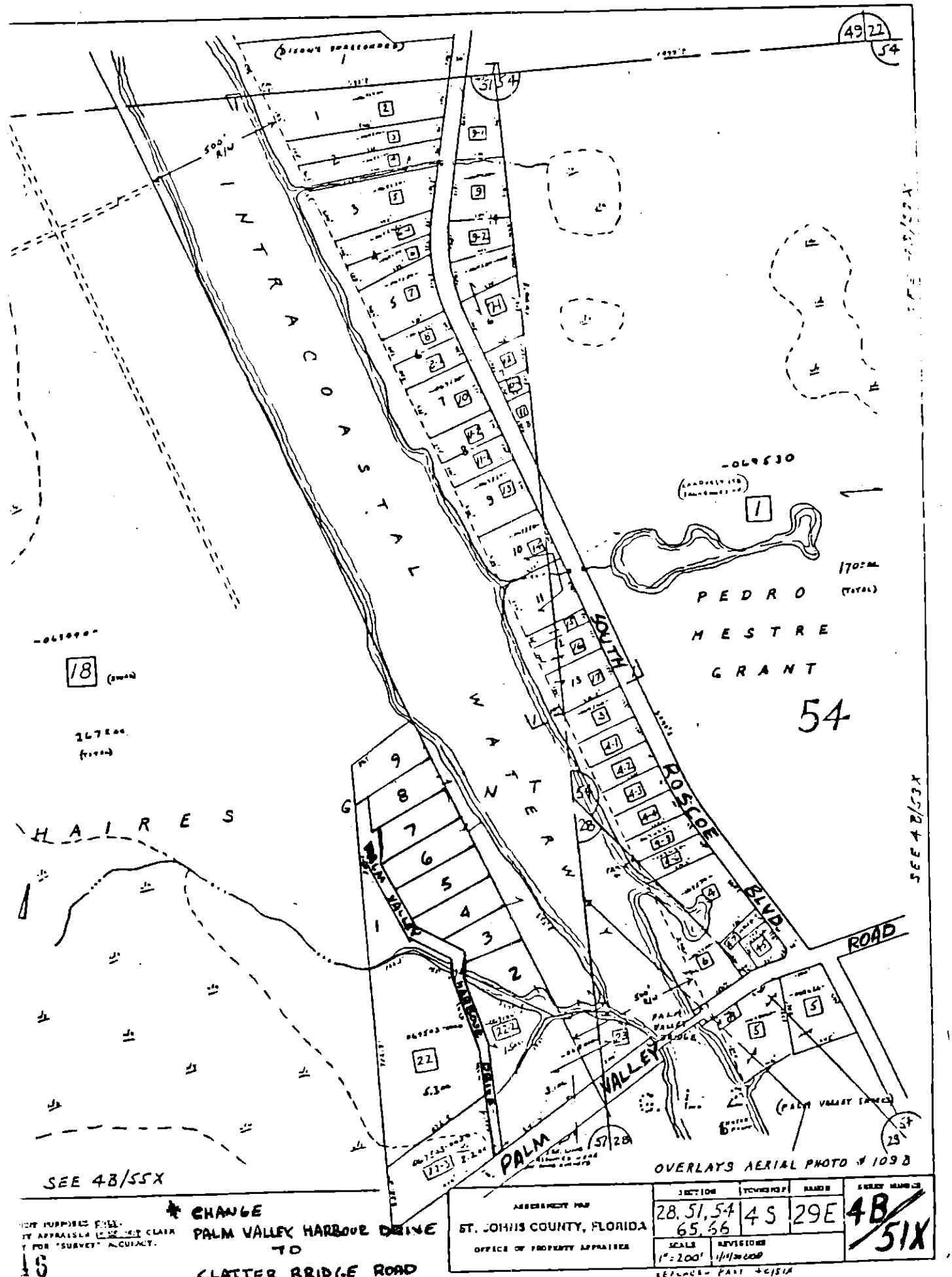



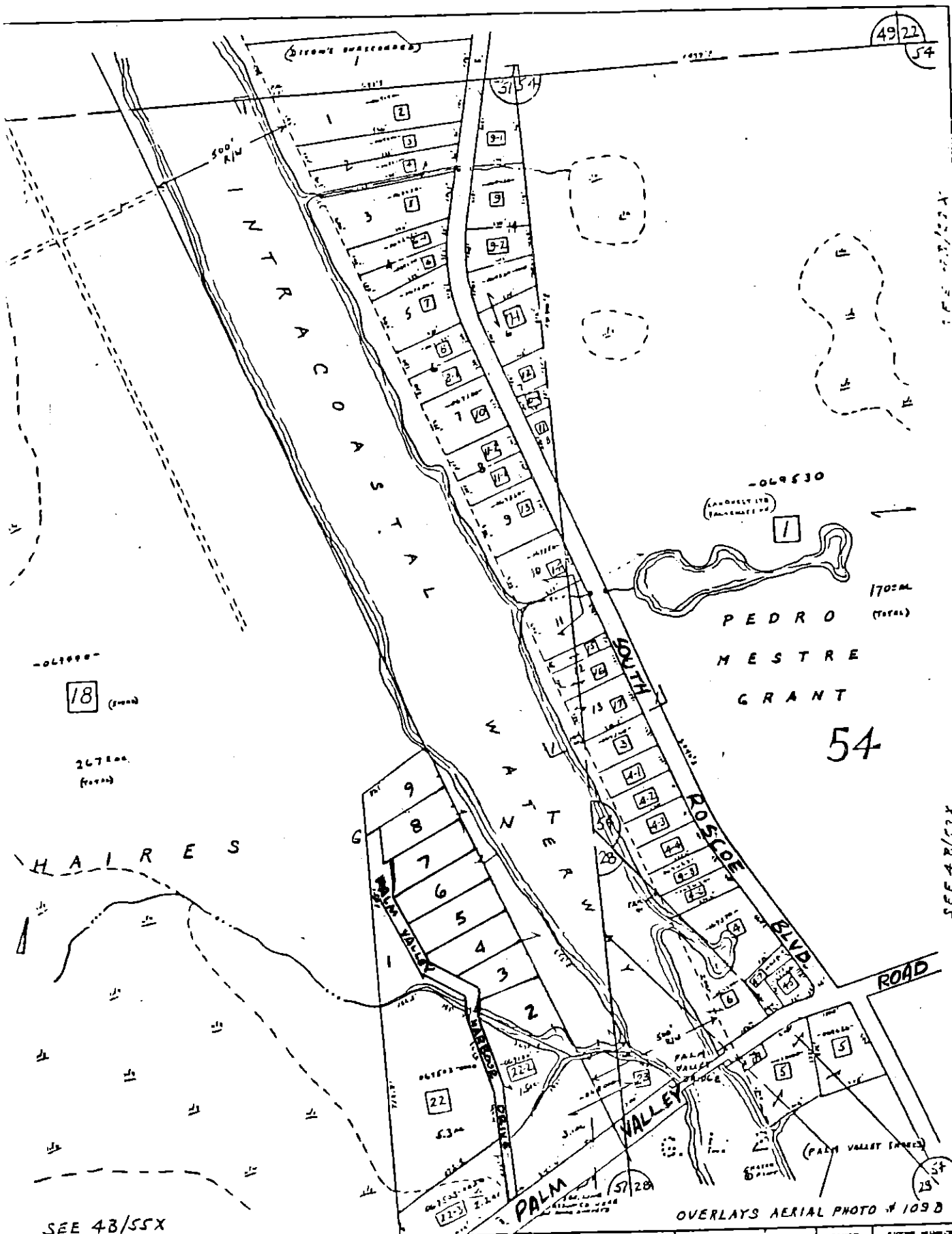
