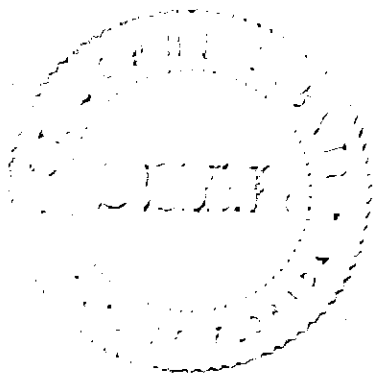
WHEREAS, an application has been duly made to the Board of County Commissioners to rename the street known as: **NO NAME ROAD**;

RESOLVED by the Board of County Commissioners of St. Johns County, Florida, this 27th day of March, 1990.



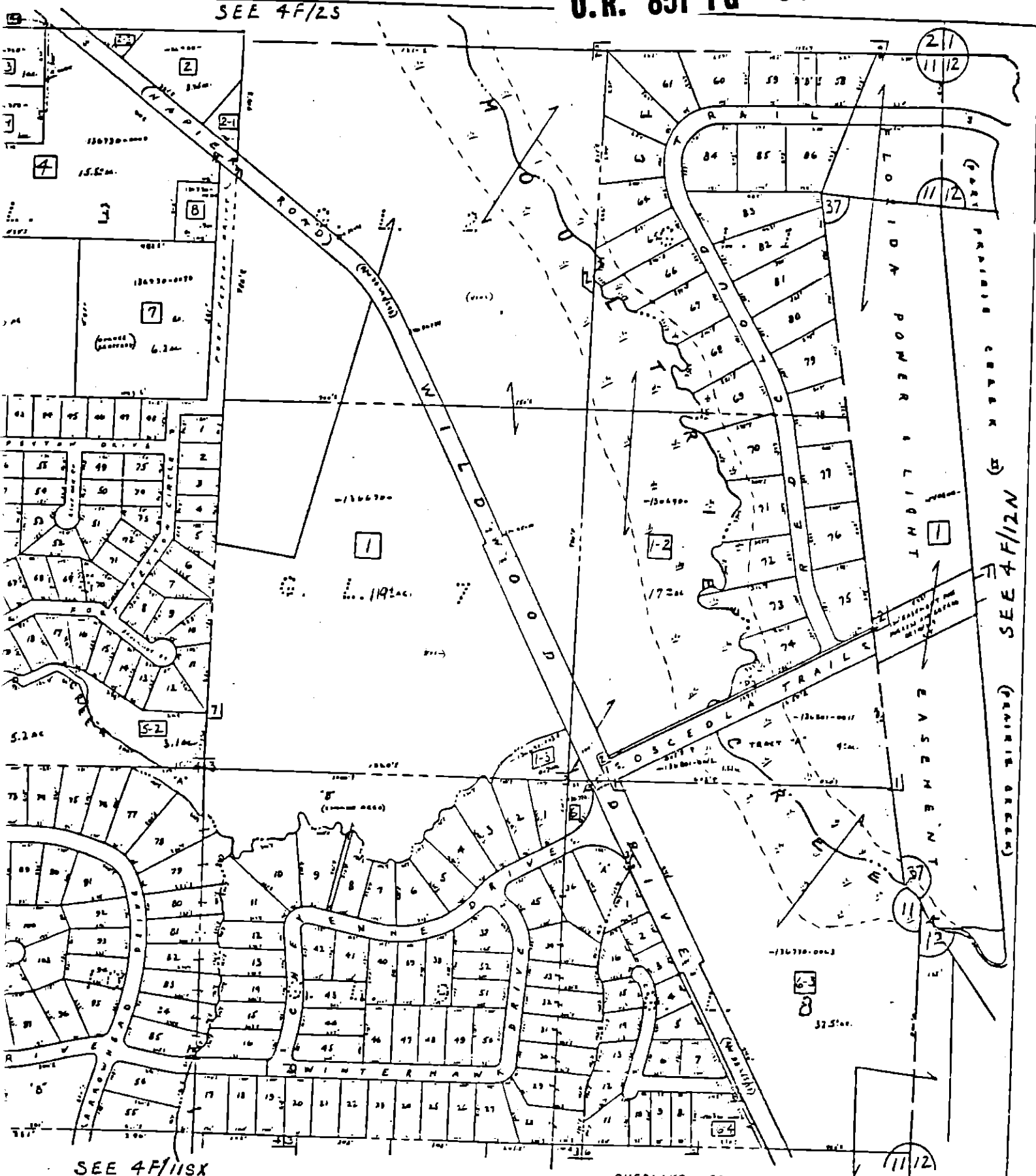


