WHEREAS, an application has been duly made to the Board of County Commissioners to rename the street known as: **NORTH & SOUTH WILDERNESS ROAD;**

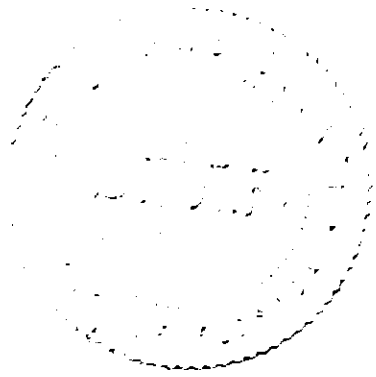
WHEREAS, it is found to be in the public interest to rename this street in furtherance of the public health, safety and welfare;

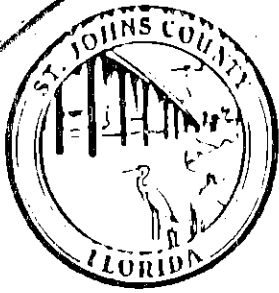

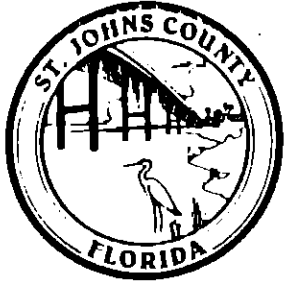
