RESOLUTION NO. 91-178

A RESOLUTION OF ST. JOHNS COUNTY, FLORIDA PROHIBITING SMOKING IN OR ON ALL PUBLIC PLACES (AS DEFINED IN FLORIDA STATUTE \$386.203) THAT ARE OWNED BY OR LEASED TO EITHER THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY OR ST. JOHNS COUNTY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Part II, Chapter 386 Florida Statutes (the "Act") provides that no person may smoke in a public place or at a public meeting except in designated smoking areas; and

WHEREAS, the Act specifically provides that (i) buildings or portions of buildings owned by or leased to a political subdivision and used for governmental purposes, (ii) retail stores, (iii) recreational facilities, (iv) libraries, (v) courtrooms, (vi) jury rooms, and (vii) auditoriums are all deemed to be public places; and

WHEREAS, the Board of County Commissioners of St. Johns County finds and determines that it is in the best interests of the citizens of the County to prohibit smoking in all public places owned by or leased to the County

NOW THEREFORE BE IT RESOLVED, BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA as follows:

Section 1. To the full extent authorized by Part II Chapter 386 Florida Statutes (the "Act") smoking is prohibited in all public places as defined in the Act that are owned by or leased to either the Board of County Commissioners of St. Johns County or St. Johns County.

Section 2. The Board of County Commissioners hereby specifically and publically declines to designate any smoking areas in the public places described in section 1 above.

Section 3. The Board of County Commissioners specifically and publically hereby prohibits any person, employee, official, or entity from designating any areas as smoking areas in the public places described in section 1 above.

Section 4. As an aid in identifying the public places described in section 1 above, but not as a limitation of such places, the following are specifically identified as public places referred to in section 1 above:

- 1. The entire St. Johns County Courthouse building located at 99 Cordova Street, St. Augustine, Florida
- 2. Each building constituting a part of the County Administration complex located at or near 4020 Lewis Speedway
- 3. Each building constituting a part of the Criminal Justice Facility complex and jail located at or near 4015 Lewis Speedway
- 4. The County library building located at or near 1960 N.

  Ponce de Leon Blvd.
- 5. Each building located on the County golf course lands
- 6. All buildings used by County Road and Bridge Department personnel
- 7. All buildings used by County Solid Waste Department personnel
- 8. That portion of the fifth floor of the First Union Bank Building used by Public Defender personnel
- 9. The additional facilities, if any, described on Exhibit A attached hereto:

Section 5. This Resolution shall take effect on November 12 , 1991
