#### RESOLUTION 91-181

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA ESTABLISHING AND FIXING THE BOUNDARIES OF THE FIVE COUNTY COMMISSIONERS' DISTRICTS IN ST. JOHNS COUNTY, FLORIDA.

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST.


JOHNS COUNTY, FLORIDA as follows:

Section 1. Pursuant to and based upon Article VIII, Section 1(e) of the Constitution of the State of Florida, Chapter 124, Florida Statutes, and other applicable Federal and State law and the redistricting requirements thereof and the written and verbal presentations made at various public meetings pertaining to this 1991 redistricting, the Board of County Commissioners of St. Johns County, Florida, hereby (i) determines and finds that the facts contained in the chart designated as the St. Johns County 1991 County Commission and School Board Reapportionment Plan, a copy of which is attached hereto as Exhibit A and incorporated by reference, which contains the population statistics on which the district boundaries set forth herein are based, and which was prepared by ATS Research of Jacksonville, Florida, are complete and accurate, and the population in each district is as nearly equal as possible; and (ii) establishes and fixes the boundaries of the five County Commissioners' Districts in St. Johns County, Florida as follows:

Reginning at the intersection of the northern boundary of St. Johns County and the Intracoastal Waterway; thence westerly along the northern boundary of St. Johns County to where said northerly boundary intersects the range line between Ranges 28 and 29 East; thence south along said range line to where said range line intersects the township line between Townships 4 and 5 South; thence west along said township line to a point where said township line intersects the range line between Ranges 27 and 28 East; thence north along said range line to where the same line intersects Durbin Creek; thence west along the south bank of Durbin Creek to Julington Creek; thence continuing west along the thread of Julington Creek to the mouth thereof; thence due west to the west margin of the main channel of the St. Johns River and the boundary line of Clay County; thence southerly along the main channel of the St. Johns river to a point due west of Tocoi Creek; thence east to the mouth of Tocoi Creek; thence easterly and northeasterly along the center of said creek to the point where it intersests the centerline of the powerlines which run north south and is 8000 feet west of County Highway 13A; thence north along the centerline of the powerlines to a point where the intersect Steven Colee Rd.; thence east and north along the centerline of Steven Colee Rd. to the point where it intersects Picolata Rd., or County Highway 208; thence easterly along Picolato Rd. to where it becomes State Highway 16 or the Charles Usinas Memorial Highway, continuing easterly to where State Highway 16 becomes Park Avenue; thence easterly along the centerline of Park Avenue to where it meets Atlantic Causeway; thence northeasterly along the centerline of Atlantic Causeway, also known as Atlantic Blvd. to the eastern boundary of the City Limits of St. Augustine; thence northerly along the City Limits of St. Augustine to the intersection with the center of Robinson Creek; thence northerly and easterly along Robinson Creek to the mouth of said creek; thence due east to the center of the Tolomato River; thence north along the center of the Tolomato River, also known as the Intracoastal Waterway to the point of beginning.

### District 2

Beginning at the intersection of the center of the San Sebastian River and State Highway 16, also known as the Charles Usinas Memorial Highway; thence westerly along State Highway 16 to where it becomes known as Picolata Road or County Highway 208; thence continuing westerly along the centerline of County highway 208 to the point where it intersects Steven Colee Rd.; thence southerly and westerly along the centerline of Steven Colee Rd. to the point where it intersects the north-south powerlines which are 8000 feet west of County Highway 13A; thence southerly along the centerline of the powerlines to a point where the powerlines intersect the center of Tocoi Creek; thence westerly along said creek to its mouth thereof; thence due west to the west margin of the main channel of the St. Johns River and the boundary of Clay County; thence southerly along said margin and boundary between Clay and Putnam Counties to a point due west of the mouth of Deep Creek; thence due east to the mouth of Deep Creek; thence southeasterly along the center of Deep Creek to a point where said creek intersects the range line between Ranges 27 and 28 East; thence south on said range line also being the boundary with Putnam County to a point where the south boundary of Section 18 in Township 10 South, Range 28 East intersects said range line; thence east on said section line, also being the boundary of Flagler County and continuing along said county line to the range line between Ranges 29 and 30 East; thence north on said range line to the middle of Pellicer's Creek; thence easterly along the center of said creek to where the creek intersects Interstate 95; thence northerly along the centerline of I-95 to its intersection with State Road 207; thence northeasterly along SR 207 to the west limits of the City of St. Augustine; thence southerly and easterly following the western and southerly limits of the City of St. Augustine to where said limits intersect the Matanzas River; thence due east to the center of the Matanzas River; thence northwesterly along the center of the Matanzas River to a point due east of the mouth of Maria Sanchez Lake; thence west and north along the center of Maria Sanchez Lake to the intersection of said lake with South St.; thence east on South St. to the intersection with St. George St.; thence north on St. George St. to the intersection of Cordova St.; thence north on Cordova St. to the intersection of King St.; thence west along King Street to a point where said street intersects the center of the San Sebastian River; thence north along the center of the San Sebastian River to the point of beginning.

Section 2. The Clerk of the Board of County Commissioners shall cause an accurate description of the above district boundaries to be entered upon the minutes of the Board and a certified copy thereof to be published once each week for 2 consecutive weeks in a newspaper published in St. Johns County. The Clerk shall enter proof of such publication in the minutes of the Board.

Section 3. The Clerk shall forthwith furnish the Department of State with a certified copy of the minutes of the Board reflecting the description of the boundaries of each district.
