RESOLUTION NO. 91-37

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, APPROVING THE FINAL ASSESSMENTS FOR THE PAVING OF CALLE CORTEZ IN PARQUE AVILES UNDER THE PROVISIONS OF ORDINANCE NO. 76-21 AS AMENDED.

WHEREAS, the Board of County Commissioners of St. Johns County, Florida, has considered the establishment of the final assessment amounts for the paving of Calle Cortez in Parque Aviles at a public hearing duly noticed and passed Resolution No. 89-176.

NOW THEREFORE BE IT RESOLVED by the Board of County Commissioners of St. Johns County, Florida as follows:

- 1. The assessments attached hereto are hereby approved. Each assessment may be divided into five equal amounts and paid in five equal annual installments, with the exception of Lot 2 Block E and Lot 4 Block E Parque Aviles, with interest on the unpaid amount added at 9% per annum. The interest shall commence to accrue on January 2, 1992. Lot 2 Block E and Lot 4 Block E Parque Aviles may be divided into ten equal amounts and paid in ten equal annual installments with interest on the unpaid amount added at 9% per annum and commencing to accrue on January 2, 1992.
- 2. Parcel #173615-0000 is exempt from assessment; said parcel measures 8 feet by 200 feet and is nonbuildable. Lot 9 Block F and Lot 13 Block J Parque Aviles are exempt from assessment; said lots were assessed for the paving of Calle Madrid.
- 3. Installments may be paid in advance without interest or penalty.
- 4. The Notice of Lien shall be prepared by the Clerk of Courts listing the name and address of each property owner at the top, and in its body listing the name, legal description, assessment amount for each piece of property, the number of annual installments, and the interest rate.
- 5. The Notice of Lien shall be recorded by the Clerk of the Board in a special book to be known as the "Road Improvement Lien Book" and also in the Official Public Records of St. Johns County.
- 6. The first installment shall become due January 2, 1992.
- 7. Principal and accrued interest may be prepaid at any time without penalty.
- 8. A copy of this resolution shall be delivered to the Clerk of the Court, the Tax Collector, and the Property Appraiser.
- 9. The Clerk shall make sure that a notice of the final assessment amount and appropriate billings are mailed to the property owners.
