PLAN DESCRIPTION

In accordance with approved ORDINANCE #86-86, the following narrative will describe the plan of development for a Temporary Final Development Plan for a sales and office facility to be located on Parcel 0-1.

This parcel is approximately .78 acres and is located on the vicinity map of the attached site plan. It is the intent of the applicant to install a fourteen (14') by seventy (70') foot modular office building, parking, and landscaping in accordance with St. Johns County Regulations.

The parcel is fully serviced with paving, drainage, (master stormwater system), sewer and water. The structure will be moved on site, skirted, landscaped, and connected to the public utilities.

A ten-space coquina shell parking lot will be constructed with a concrete apron from the existing edge of pavement to the property line.

This Temporary Final Development Plan will be good for a period of three years from date of approval by the St. Johns County Commission. The applicant requests the right to extend this temporary plan an additional two years from this date if all parcels are not sold or developed.

The purpose of this facility is to market and sell the 40 acre PUD, as well as provide temporary offices for preleasing and construction of improvements.

This application is in accordance with the approved ORD. #86-86, Article 8, Section 8-3 Implementation of a PUD, St. Johns County Zoning Ordinance.

Upon approval, this Temporary Final Development Plan will be recorded as per Article 8, Section 8-3-3, and permits will be obtained as per Section 8-3-4.
