

RESOLUTION NO. 91-67

A RESOLUTION AUTHORIZING EXECUTION OF A RAILROAD REIMBURSEMENT AGREEMENT FOR THE INSTALLATION OF GRADE CROSSING TRAFFIC CONTROL DEVICES, AND FUTURE MAINTENANCE AND ADJUSTMENT OF SAID DEVICES; PROVIDING FOR THE EXPENDITURE OF FUNDS AND PROVIDING WHEN THIS RESOLUTION SHALL TAKE EFFECT.

WHEREAS, the State of Florida Department of Transportation is constructing , reconstructing or otherwise changing a portion of the Public Road System, which shall call for the installation and maintenance of railroad grade crossing traffic control devices for railroad grade crossing over or near said highway,

NOW THEREFORE BE IT RESOLVED, by the St. Johns County Board of County Commissioners of St. Johns County, Florida,

That St. Johns County enter into a Railroad Reimbursement Agreement with the State of Florida Department of Transportation and the Florida East Coast Railroad Company for the installation and maintenance of certain grade crossing traffic control devices designated as Job No. 78-XXX-XXXX on King Street which crosses the right of way and tracks of the Company at FDOT/AAR Crossing No. 271887-B located near St. Augustine, Florida, and

That the County assume its share of the costs for future maintenance and adjustment of said grade crossing traffic control devices as designated in the Railroad Reimbursement Agreement; and

That the Chairman and the Clerk of the Board of County Commissioners be authorized to enter into such agreements with the State of Florida Department of Transportation and the FEC Railroad Company as herein described.

That this resolution shall take effect immediately upon adoption.

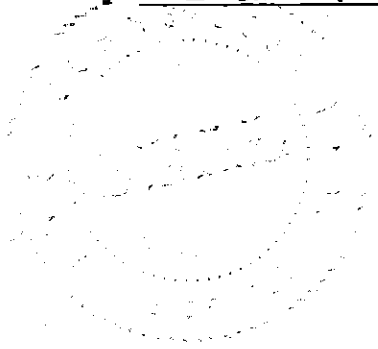

Dear Mr. Castle:

Please be advised, that the referenced crossing is in the Safety Program for railroad signal installation for fiscal year 1991-1992. This crossing was selected on a state-wide priority.

The estimated cost of Type IV Class III signals at this location is \$75,000.00. The Federal Highway Administration agrees to pay ninety percent (90%) and the Florida Department of Transportation will be responsible for the remaining ten percent (10%) of the total installation cost. The annual maintenance cost of Type IV Class III signals at the location is \$980.00. The County is responsible for fifty percent (50%) of the annual maintenance cost and the railroad company is responsible for the remaining fifty percent (50%).

A resolution is required by the Department from the County before any preliminary engineering can be started by the railroad company.

Please execute the enclosed resolution or furnish me with a letter stating that the County objects to installing railroad signals at this location.
