
2. That the application fee in the amount of \$25.00 for renaming of the street is waived.

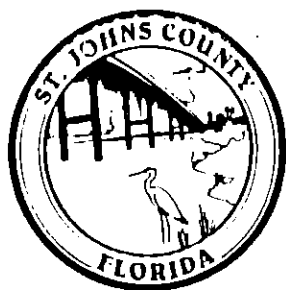
