A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA RATIFYING AND ADOPTING THE SOLID WASTE FRANCHISE AGREEMENTS BETWEEN THE COUNTY AND SEABOARD SANITATION, INC. DATED JANUARY 23, 1990 AND BETWEEN THE COUNTY AND BROWNING FERRIS INDUSTRIES OF FLORIDA INC. DATED JANUARY 23, 1990 AND AUTHORIZING THE CHAIRMAN TO SIGN AGREEMENTS BETWEEN THE COUNTY AND SEABOARD SANITATION, INC. AND BETWEEN THE COUNTY AND BROWNING FERRIS INDUSTRIES OF FLORIDA, INC. THAT RATIFY AND ADOPT THE RESPECTIVE JANUARY 23, 1990 SOLID WASTE FRANCHISE AGREEMENTS.

WHEREAS, uncertainty has arisen as to whether the Solid Waste Franchise Agreements between the County and Browning Ferris Industries of Florida, Inc. dated January 23, 1990 and between the County and Seaboard Sanitation, Inc. dated January 23, 1990 (collectively "the Solid Waste Franchise Agreements") are void or voidable because notice of the January 23, 1990 hearing on the agreements was not published in a newspaper (although the hearing on the matter was noticed by the preprinted agenda for the January 23, 1990 hearing); and

WHEREAS, the following notice was published in the St. Augustine Record on September 25, 1992:

AUGUSTINE, FLORIDA, WILL HOLD A PUBLIC HEARING TO DETERMINE WHETHER OR NOT TO RATIFY AND ADOPT THE SOLID WASTE FRANCHISE AGREEMENTS BETWEEN THE COUNTY AND SEABOARD SANITATION, INC. DATED JANUARY 23, 1990 AND BETWEEN THE COUNTY AND BROWNING FERRIS INDUSTRIES OF FLORIDA, INC. DATED JANUARY 23, 1990 AND IF APPROPRIATE, TO RATIFY AND ADOPT THOSE AGREEMENTS.

- 2. The Chairman is authorized and directed to sign agreements between the County and Seaboard Sanitation, Inc. and between the County and Browning Ferris Industries of Florida, Inc. that ratify and adopt the January 23, 1990 Solid Waste Franchise Agreements.
