A RESOLUTION OF THE ST. JOHNS COUNTY,
FLORIDA BOARD OF COUNTY COMMISSIONERS
RENAMING A STREET FROM INDUSTRIAL PARK ROAD
TO ROLLING HILLS DRIVE.

WHEREAS, an application has been duly made to the Board
of County Commissioners to rename the street known as Industrial
Park Road; and

WHEREAS, the procedure outlined in Resolution No. 92-65
has been followed by the petitioners; and

WHEREAS, the E-911 Coordinator has reviewed the
petition, and recommends that it be granted; and

WHEREAS, it is found to be in the public interest to
rename this street as requested in furtherance of the public
health, safety and welfare.

NOW THEREFORE, BE IT RESOLVED AS FOLLOWS:

1. The petition to rename Industrial Park Road is hereby granted.
2. The street name known as Industrial Park Road is hereby renamed to Rolling Hills Drive, and shall hereafter be known by that name.
3. The E-911 Coordinator is instructed to take whatever steps are necessary to change the street name and to notify the Property Appraiser's office of the change.

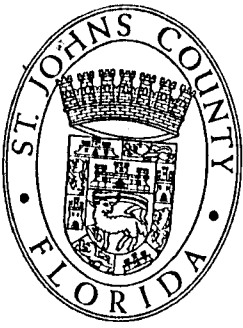

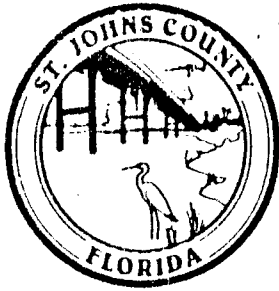

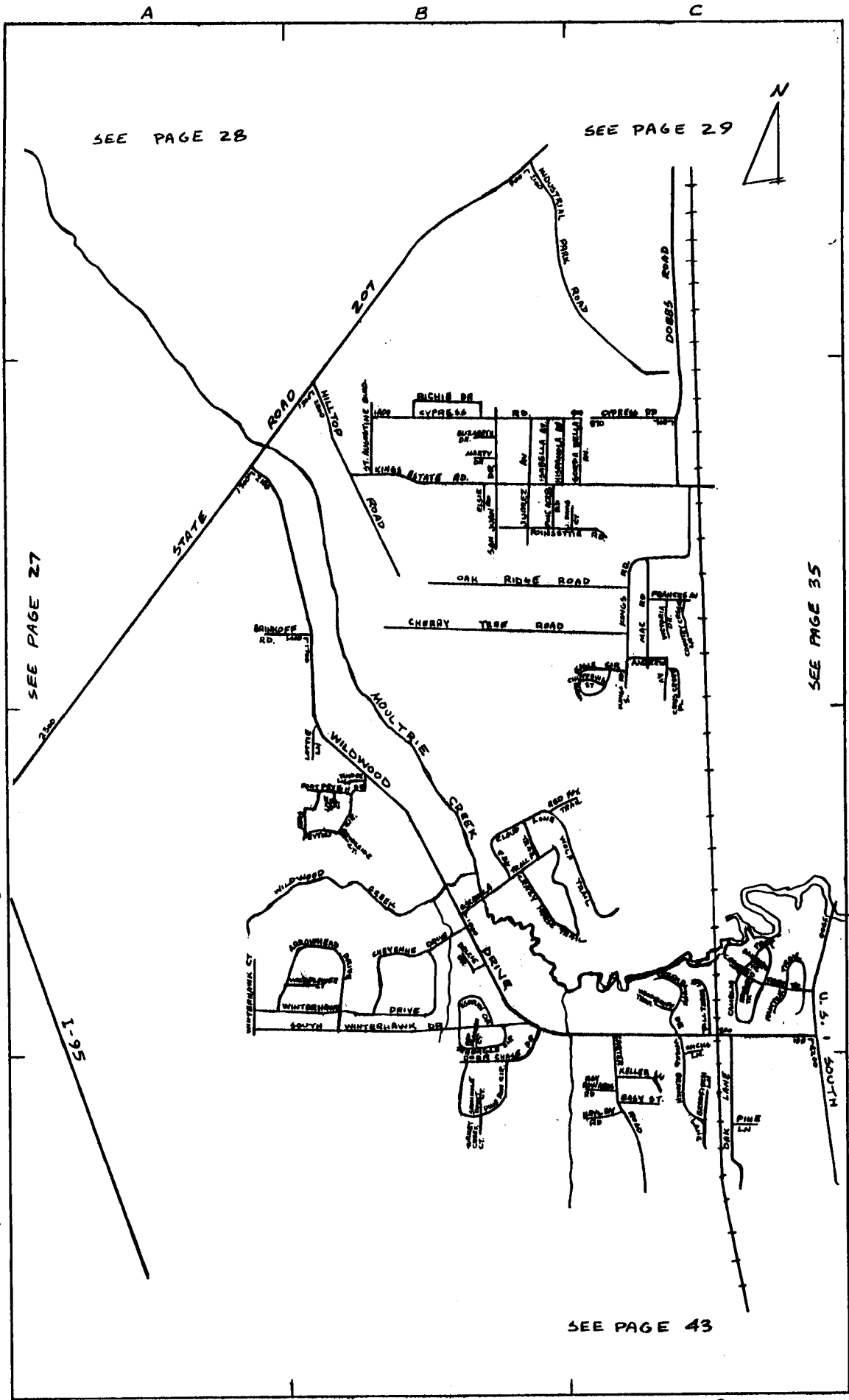
