

RESOLUTION NO. 92-181

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA AUTHORIZING COUNTY PERSONNEL TO EXECUTE COUNTY PURCHASE ORDERS WITHOUT BIDS FOR CERTAIN GOODS, SUPPLIES, EQUIPMENT AND MATERIALS DESCRIBED IN ST. JOHNS COUNTY RENOVATIONS TO ROAD AND BRIDGE DEPARTMENT THAT IS PART OF THE COUNTY'S CONTRACT WITH COMPONENT FABRICATORS, INC.

**WHEREAS**, the Board of County Commissioners advertised for, and received bids for the renovation of the St. Johns County Road & Bridge Department; and

**WHEREAS**, Component Fabricators, Inc. was awarded the construction contract dated July 28, 1992; and

**WHEREAS**, the bid documents and the contract provided for the Contractor to prepare purchase orders for equipment, materials, and supplies to be purchased directly by the County to enable such purchases to be exempt from the Florida Sales Tax without the County incurring undue risks concerning timely delivery of the items to the trade contractors performing the construction and installation of the work described in the construction contract; and

**WHEREAS**, advertising once each week for two weeks for bids for certain materials, equipment and supplies described in the previously advertised and awarded construction contract would be redundant and would cause chaos in the scheduling of construction and unduly delay completion of the project.

**NOW THEREFORE BE IT RESOLVED**, by the Board of County Commissioners of St. Johns County that:

- Section 1.** County personnel are hereby authorized to sign County purchase orders prepared by Component Fabricators, Inc. pursuant to it's contract with the County dated July 28, 1992 for supplies, materials and equipment for the St. Johns County Renovation of Road and Bridge Department and such supplies, materials, and equipment may be purchased and paid for without advertising, or County bids.

- Section 2.** Such supplies, materials, and equipment are already included in the lump sum contract for the St. Johns County Renovation of Road and Bridge Department and the County will receive an appropriate deduct when the County purchases such goods.
- Section 3.** Such supplies, materials, and equipment were included as part of the previously advertised request for bids for the construction of the St. Johns County Renovation of Road and Bridge Department.
- Section 4.** Such supplies, materials, and equipment cannot be obtained in sufficient time if bids, public notice and advertisement are again required.
